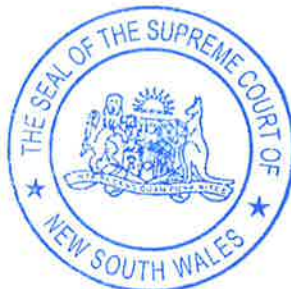

### TERMS OF JUDGMENT/ORDER

1. I give leave to the plaintiff to file in court interlocutory process, draft form of order and affidavit of David John Frank Lombe sworn 18 November 2011.
2. I make orders in terms of the short minutes of order initialled by me and dated today's date.  
Orders:
  1. Pursuant to section 439A(6) of the Corporations Act 2001 (Cth) (the Act), the period under section 439(5) of the Act within which the first plaintiffs must convene the meeting of creditors required under section 439A of each of the second plaintiff, third plaintiff and fourth plaintiff (together the Companies) be extended up to and including 29 February 2012.
  2. Pursuant to section 447A(1) of the Act, the second meetings of creditors of each of the Companies required by section 439A of the Act may be held at any time during, or within five (5) business days after the end of, the convening period, as is extended by order 1 above, notwithstanding the provisions of section 439A(2) of the Act.
  3. Liberty to apply be granted to any person who can demonstrate sufficient interest to modify or discharge these orders upon appropriate notice being given to the first plaintiffs.
  4. The cost of this application be paid out of the assets of the Companies.
  5. These orders be entered forthwith.
