**APPLICATION FOR BANKRUPTCY ORDER**

Alberta Treasury Branches (the "Petitioner"), hereby applies to the Court that Penn-Tek Truss & Floor Systems Inc. (the "Debtor") be adjudged bankrupt and that a Bankruptcy Order be made in respect of the property of the Debtor, a body corporate registered and carrying on business under the laws of the Province of Alberta and within the jurisdiction of the Court, and the Petitioner **SAYS THAT:**

1. The Debtor is a corporation authorized to carry on business under the Business Corporations Act of Alberta and has an office to and carries on business in Alberta;
  2. That the Debtor has at some time during the six months next preceding the filing of this petition carried on business throughout the Province of Alberta and within the jurisdiction of this Court;
  3. That, as of June 6, 2008, the Debtor is justly and truly indebted to the Petitioner in the total approximate sum of \$1,311,976.72; plus interest and costs on solicitor and client basis, now or hereinafter incurred by the Petitioner to recover such indebtedness;
  4. That the Petitioner estimates the value of their secured claim against the Debtor as \$1,310,976.62 and their unsecured claim as \$1,000.00;
  5. That the Debtor, within the six months next preceding the date of the filing of the Petition, has committed the following acts of bankruptcy, namely:
    - (a) The Debtor has ceased to meet its liabilities generally as they have become due;

6. That Victor Kroeger of Deloitte & Touche Inc. is a licensed Trustee in Bankruptcy qualified to act as Trustee of the property of the Debtor and has agreed to act and as such is acceptable to the Petitioner; and


7. That the Court, if necessary, shorten the period of time for service of this Petition, the Notice of Hearing and Affidavit of Truths, pursuant to s. 70 of the *Bankruptcy and Insolvency General Rules*.


