UPON THE APPLICATION of DaimlerChrysler Truck Financial, a business unit of DCFS Canada Corp. (DCFS) a creditor.; AND UPON READING the Affidavits of Bruce McIntyre; AND UPON NOTING the affidavit of service of the Application and Supporting Documents together with the ORDER Abridging Time for Service; AND UPON NOTING THAT DCFS estimates the value of its security on the assets of Peace Country Freightliner Inc. will result in a deficiency of approximately \$2,695,333.00; AND UPON IT APPEARING to the Court that the following acts of BANKRUPTCY have been committed by PEACE COUNTRY FREIGHTLINER INC.:

- a. It has ceased to meet its liabilities generally as they have become due.

2. It is further Ordered that Deloitte & Touche Inc. of the City of Calgary, in the Province of Alberta be and is hereby appointed Trustee of the Estate of Peace Country Freightliner Inc.
3. Deloitte & Touche Inc. is hereby directed to give security in the amount to be fixed by the Official Receiver pursuant to s.16(1) of the *Bankruptcy and Insolvency Act*.
4. Costs of this Application shall be paid to the Creditor out of the Estate of Peace Country Freightliner Inc. upon the taxation thereof.
