ORDER

THIS MOTION made by Deloitte and Touche Inc. as Trustee for the Bankrupt, Ledco Limited (the "Trustee") for advice and directions in relation to the administration of the estate of the Bankrupt, Ledco Limited and advice and directions in relation to the enforcement of the Order and Warrant dated January 25, 2008 was heard today at London, Ontario.

ON READING the Notice of Motion of the Trustee filed and upon hearing the submissions of counsel for the Trustee, CAW National, TD Canada Trust, Waterloo Regional Police Services and Cooper Standard Inc:

1. THIS COURT ORDERS that service of the Order and Warrant dated January 25, 2008 on the CAW National is effective today, January 27, 2008;
2. THIS COURT ORDERS the Waterloo Regional Police Services shall attend at the Bankrupt's premises located at 1530 Strasburg Road, Kitchener, Ontario (the "Ledco Premises") this afternoon and serve the occupiers of the Ledco Premises a photocopy of the Order and Warrant dated January 25, 2008 together with a copy of the endorsement of this court dated January 27, 2008;
3. THIS COURT ORDERS the Waterloo Regional Police Services is permitted to obtain and disclose to the Trustee the names of those persons served pursuant to paragraph 2 above and the circumstances of service;
4. THIS COURT ORDERS the Trustee may maintain private security guards on the Ledco Premises;
5. THIS COURT ORDERS that possession of the Ledco Premises must be delivered to the Trustee by no later than 4 p.m. today, Sunday January 27, 2008;
6. THIS COURT ORDERS that there be no order regarding proceedings for contempt as at the date of this Order.
