2. An Order abridging the time for service of the notice of this application;
3. An Order adjudging Penn-Tek Truss & Floor Systems Inc. ("Penn-Tek") bankrupt;
4. A Bankruptcy Order in respect of the property of Penn-Tek;
5. Such further and other relief as this Honourable Court may deem just.

AND FURTHER TAKE NOTICE THAT the grounds of this application are that:

- (a) Within the last six months, Penn-Tek has committed an act of bankruptcy, namely it has ceased to meet its liabilities generally as they have become due.



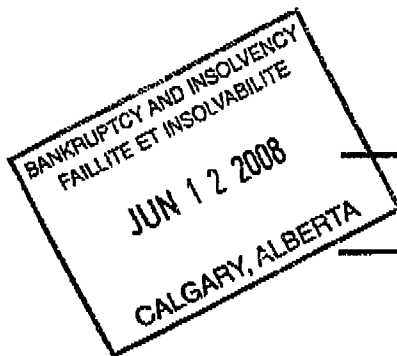
