THIRD ORDER AMENDING CLAIM PROCEDURE



(the "Monitor" and "Caribou", respectively); AND UPON READING the Third and Fourth Monitor's Report dated May 24, 2007 and May 31, 2007, respectively; AND UPON the Court extending the stay to June 14, 2007; AND UPON HEARING counsel for the Monitor, counsel for Caribou and counsel for other interested parties;

IT IS HEREBY ORDERED AND DECLARED THAT:


1. The Claims Procedure Order granted by this Honourable Court on February 22, 2007 and amended by the Court Order dated May 3, 2007, is hereby further amended to provide that the stay of paragraph 5(d) is hereby vacated and the operation of paragraph 5(d) is hereby reinstated and the fourteen (14) day time period in which a Creditor may file a Notice of Motion shall commence to run from June 12, 2007.
2. This Order does not apply to any Claims which are barred as a result of the failure of a Claimant, whose Claim was Disallowed by the Monitor, to file a Notice of Motion within fourteen (14) days where the expiry of the time within which to file a Notice of Motion


expired on or before May 3, 2007. All such claims are subject to the terms of the Claims Procedure Order.

3. The Monitor is hereby directed to post a copy of this Order on its website, www.deloitte.ca, under the Insolvency and Restructuring link (the "Website") and serve this Order by email, fax or courier on every party affected by the Second Order Amending Claim Procedure.
