DaimlerChrysler Truck Financial, a business unit of DCFS Canada Corp. (the "Secured Creditor") holds a General Security Agreement dated November 24, 2005, a Dealer Retail In-House Lease Financing and Security Agreement dated November 24, 2005, and a Security Agreement – Cross Collateralization dated November 24, 2005 (collectively the "Security"), which were registered in Alberta on January 13, 2006 as registration no. 06011325211 and in British Columbia on December 6, 2006 as registration no. 727708C, which were given to it by Peace Country Freightliner Inc. (the "Debtor") as part of the security for the payment and satisfaction of any and all obligations, indebtedness and liabilities of the Debtor to the Secured Creditor. In the Security, the Debtor granted to the Secured Creditor a security interest in the present and after acquired personal property of the Debtor including the inventory, accounts, chattel paper and proceeds, all as more particularly described in the Security (the "Collateral").

The undersigned hereby declares that one or more events of default have occurred or have been committed by the Debtor and the Security has therefore become enforceable pursuant to its provisions. The Secured Creditor has issued a Notice of Intention to Enforce its Security pursuant to the *Bankruptcy and Insolvency Act* and the time period for the Notice has lapsed. The Secured Creditor has reviewed the Security and is satisfied as to its entitlement to appoint a Receiver at this time.

The Secured Creditor further advises that, to the best of its knowledge and belief, there are no persons having claims in priority to its security, apart from those claims given priority by statute.

The Secured Creditor hereby appoints Deloitte & Touche Inc. (the "Receiver") to be the Receiver pursuant to the Security with all and every power and authority specified by the Security in this regard, and instructs the Receiver to seize, protect and realize upon the Collateral for the benefit of the Secured Creditor.

All monies received by the Receiver after providing for all costs, charges and expenses of, or incidental to, the exercise of any of its powers, including legal fees, shall be applied in and towards the satisfaction of any and all obligations, debts and liabilities of the Debtor to the Secured Creditor.

The rights and powers conferred hereby are in supplement to, and not in substitution of, any rights of the Secured Creditor from time to time.
