- (a) the Receiver may require borrowing capabilities in excess of the maximum amount authorized under paragraph 20 of the Initial Order to complete the engagement; and
- (b) such increase is as a result of increased costs incurred in completing the existing drilling program.

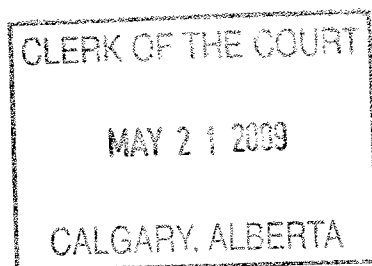
