### **ING Marathon**

#### **Deloitte Luxembourg and the Luxembourg Red Cross join forces for a good cause**

As part of the partnership with the Luxembourg Red Cross, Deloitte S.A. has, as in previous years, contributed 3€ for each kilometer run by the *Croix-Rouge-Deloitte* team. With a total of 158 runners, the team's efforts resulted in a donation of 8,157€.

84 employees from Deloitte Luxembourg and 74 runners from the Luxembourg Red Cross participated in this year's initiative, covering a total of 2,719km.

A cheque with the total amount was officially handed over to Marc Crochet, Director of Operations at the Luxembourg Red Cross, by Olivier Maréchal, Partner at Deloitte Luxembourg.

Dans le cadre de son partenariat avec la Croix-Rouge luxembourgeoise, Deloitte S.A. a contribué à la récolte de dons 3€ pour chaque kilomètre parcouru par l'équipe *Croix-Rouge-Deloitte*. Composée de 158 marathoniens, cette dernière a récolté 8 157 €.
