

- Deal structuring, which may include:
 - revision of proposed terms and conditions
 - advice on legal and tax implications of proposed deal structure
 - advice on more favourable options of structuring the deal
 - advice on purchase mechanisms
- Legal due diligence of target company in cooperation with financial advisory and tax teams at all stages to identify/assess risks and prepare risk management recommendations
- Recognition of risks identified during due diligence in contractual documents, including representations and warranties, indemnities, and price correction mechanisms
- Preparation, negotiation and execution of preliminary documents: term sheets, letters of intent, memorandum of understanding, confidentiality agreements, non-disclosure agreements etc.
- Preparation of main contractual documentation such as (i) share purchase agreements; (ii) asset purchase agreements; and (iii) investment and shareholder agreements reflecting:
 - legal, tax and financial aspects of preferred deal structure
 - major terms of governance of target company
 - conditions precedent to completion
 - conditions subsequent upon completion
 - covenants
 - events of default and exit provisions
 - compliance with mandatory provisions of local legislation
- Legal support with obtaining preliminary antimonopoly clearance for deal and filing subsequent transaction notifications
- Legal support with satisfaction of conditions precedent
- Legal support with transfer of title to assets of target company, transaction settlements, corporate and registration procedures
- Legal support with satisfaction of post-closing obligations
- Legal support with execution and registration of share purchase agreement (SPA) including:
 - collection of supporting documents such as shareholders' corporate documents, spousal consent (for individual sellers), shareholder consent forms etc.
 - drafting necessary corporate resolutions and powers of attorney
 - drafting amendments to the charter or drafting a new charter from scratch
 - advice on any matter related to execution, local notarization and registration of SPA
 - filing documents with state authority and collecting updated registration documents.
