Due diligence

We perform an independent compliance review on an existing or potential counterparty of the Company. The aim is to reveal indications of a violation of the Company's compliance policies and local & international anti-corruption legislation requirements.

We analyze the maturity of compliance functions in line with the requirements of local anti-corruption legislation, FCPA and UK BA.

We can develop an end to end compliance program or improve an existing programme. This can include the development of a Code of Ethics and compliance policies and processes for due diligence, hot line, continuous monitoring, disciplinary measures, management commitment, along with communication and trainings.

We conduct and / or assist with internal fraud and misconduct investigations by company management and employees, including those based on whistleblower reports through a hotline.

We thoroughly assess the subject's reputation, business assets, connections and contacts to identify if a subject has provided reliable information and / or whether there are any hidden reputational risks associated with the subject.

Compliance / FCPA review for an international pharmaceutical company

Our team conducted an analysis of transactions involved in the following key processes of the client's offices in the CIS (Kazakhstan, and Ukraine):

- sales (pricing, discounts, bonuses for distributors);
- purchases of goods and services, including marketing;
- employee remuneration;
- relationships with health care providers and government agencies.

We identified the following issues:

- a number of potentially fraudulent transactions, such as:
 - a) office rental from a company affiliated with the CEO of a subsidiary of the client;
 - b) purchase of souvenirs at inflated prices;
 - c) acceptance of consulting services without documentary evidence from companies with potential links to organized crime;
- violations of international law with regard to relations between pharmaceutical companies and health care providers (gifts, complimentary international travel, acceptance of lecture services without documentary evidence, etc.).

Based on our findings, we provided the client with recommendations for improving the analyzed processes, as well as measures to minimize the risks associated with the identified violations.

FCPA due diligence for a pharmaceutical company

Deloitte was engaged by a major pharmaceutical company to assist in bringing the company's expenditures into compliance with the US FCPA, as well as in line with the company's internal policies, including compliance provisions.

We identified many expenses that did not comply with the company's internal policies and which could increase FCPA risks.

The company used our recommendations to improve their internal procedures and compliance policies.
