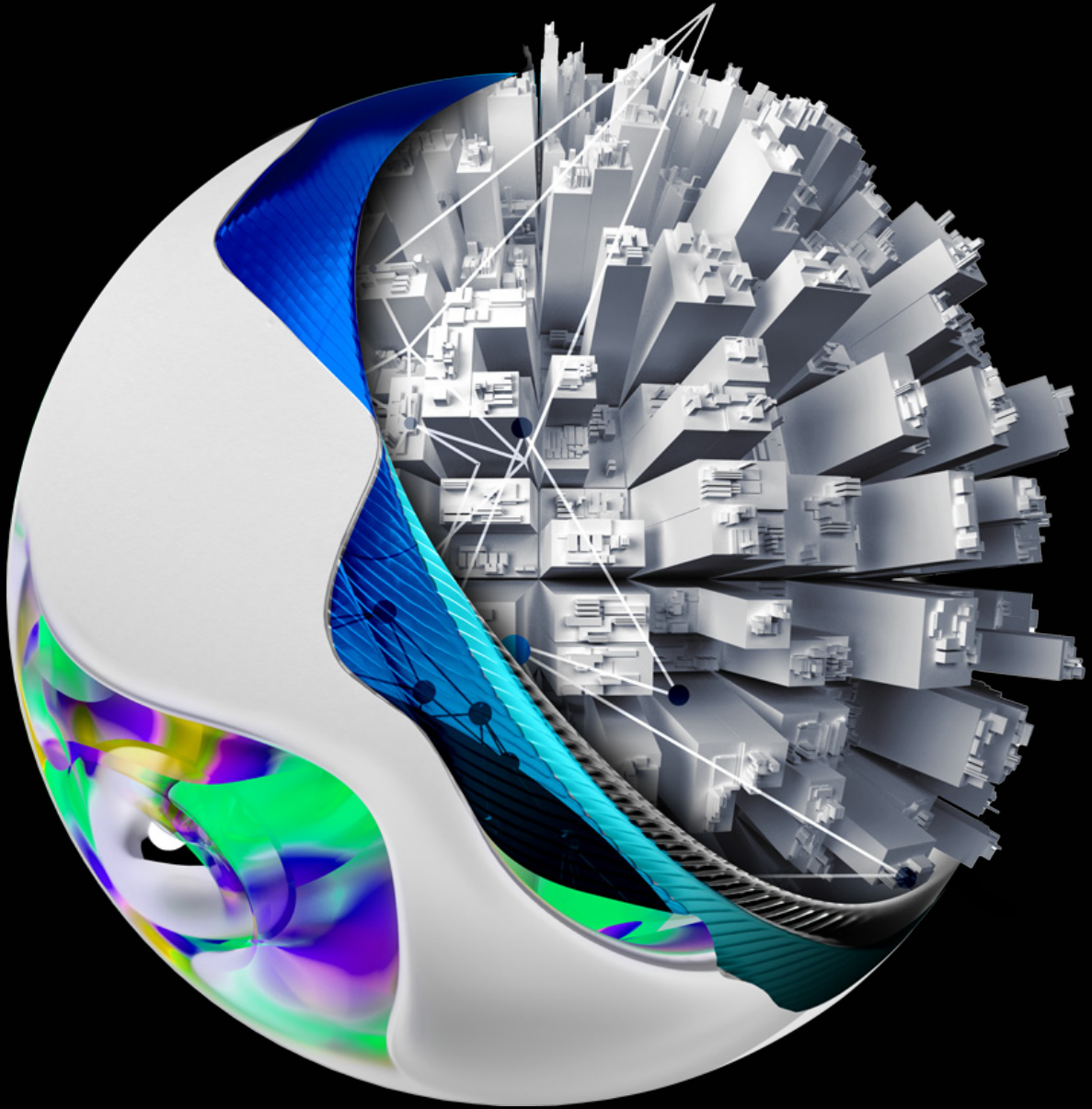

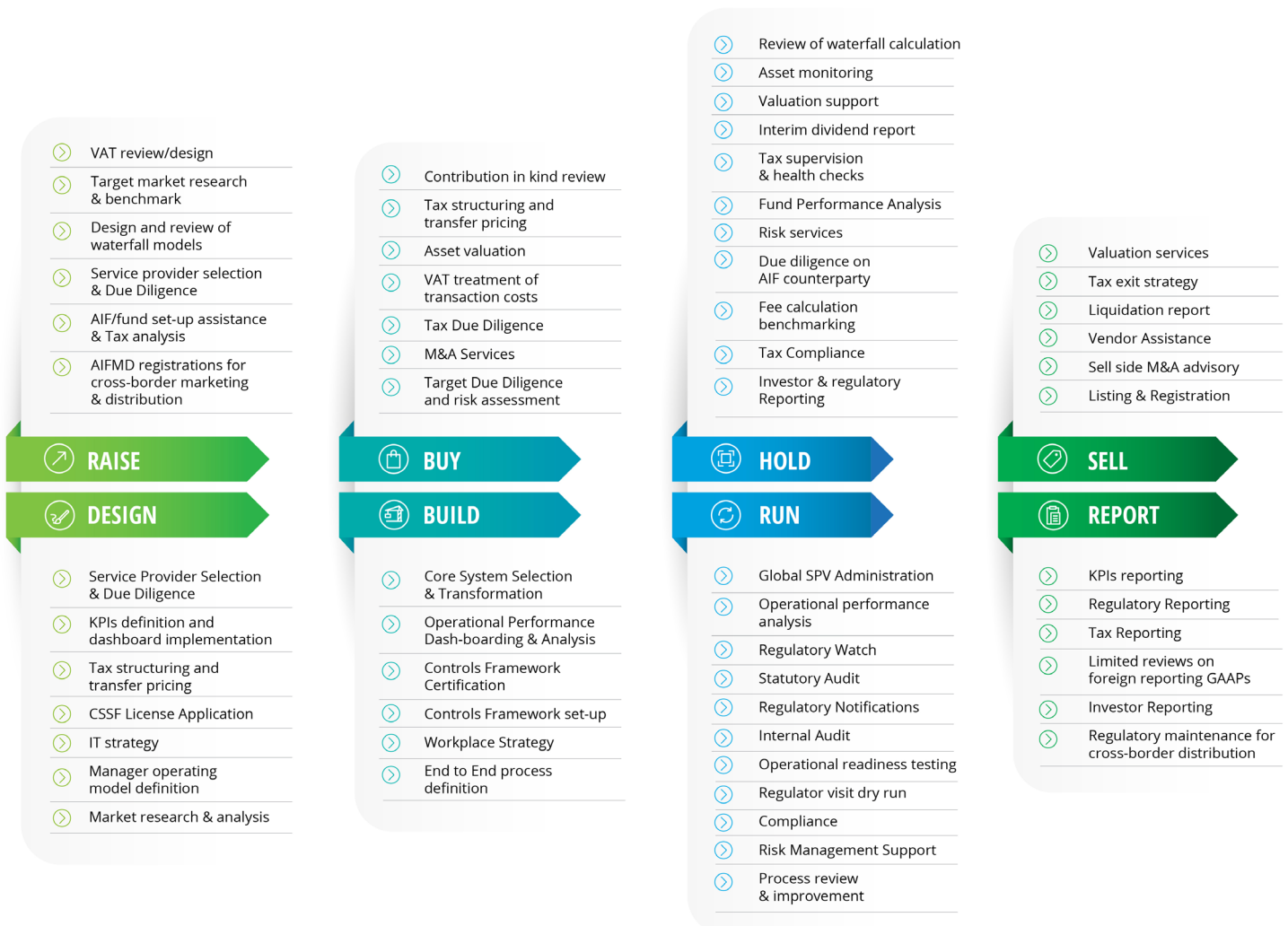
Fund Lifecycle
