    3 Rates vary according to the percentage of ownership, and whether the payments are made to an individual or a corporation.
    4 The treaty with China does not apply to Hong Kong.
    5 Under the Canadian Income Tax Act and under the Fifth Protocol to the Canada-US treaty, (non-contingent) interest paid to both arm's length and non-arm's length parties is not subject to withholding tax.
