The Comprehensive Double Taxation Agreement (CDTA) for Hong Kong-Belarus has entered into force since 30 November 2017 after the completion of ratification procedures. The CDTA will be in effect starting from the year of assessment 2018/19 in Hong Kong and 1 January 2018 in Belarus.

The Hong Kong-Belarus CDTA was signed in January 2017 and can be downloaded from this link.
