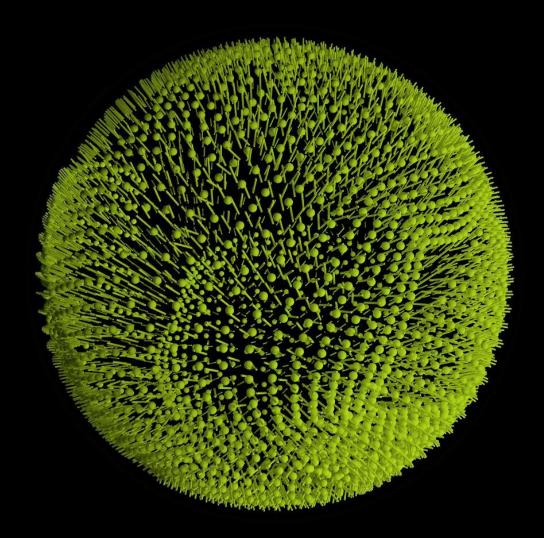

Techonolgical risks

- Inappropriate structure of input, test or validation data
- Poorly chosen algorithms distorting the model output and reducing its quality
- Definition of metrics and their thresholds, which can be used to indicate risks arising from using the model
- External open-source platforms can compromise security and their irregular maintenance can disrupt functionality
- Use of outdated software makes it impossible to work with dynamic datasets and does not allow to use their full potential
