

Tax Alert SAT declares 09 October and 10 October 2023 as non-business days, only for purposes of calculating the terms for filing appeals

In light of the current situation in the country, the Superintendency of Tax Administration -SAT- announced on its social media platforms (Facebook, Instagram and X) that it declares 09 October and 10 October 2023 as non-business days, only for purposes of calculating the terms for filing the appeals established in the tax, customs and administrative legislation and not for purposes of tax filing deadlines.

This provision guarantees the right to defense of those taxpayers that must file appeals, but cannot do so due to the current situation in the country. Depending on

how this situation evolves, SAT may adopt this same provision for subsequent days.

It is recommended that taxpayers with deadlines for filing appeals that fall on these dates take this into consideration and be on the alert for any announcements made through the Tax Administration's official channels in the coming days, in order to properly calculate the terms for asserting their defense.
