## No email confirmation/acknowledgment when using eAFS

Due to technical issues in the Bureau of Internal Revenue's (BIR) electronic Audit Financial Statements (eAFS) System, certain taxpayers failed to receive confirmation/acknowledgment emails for scanned copies of documents uploaded on said system. Thus, in lieu of the confirmation/acknowledgment email, copies of screenshots from the eAFS showing the company and the uploading of the attachments to the income tax return shall be considered sufficient proof of submission to the BIR.
