

Deloitte supports Vietnam in meeting standards of digital economy



Deloitte participated in the 2018 World Economic Forum (WEF) on ASEAN held in Hanoi, Vietnam from 11 to 13 September. Under the theme, "ASEAN 4.0: Entrepreneurship and the Fourth Industrial Revolution", the meeting gathered global and regional leaders from the government, business, and civil society. On his part, Deputy PM Hue praised Deloitte for training the people of Vietnam and other countries in the region, as well as in helping to raise the scale and quality of the Vietnam Association of Certified Public Accountants' operations.

Philip Yuen, Deloitte Southeast Asia CEO, was one of the four Technology Discussion Leaders for the "Accelerating Trade and Investment in Asia Pacific" breakout session. He touched on key issues such as the benefits of attracting foreign direct investment (FDI) for developing countries and businesses practices that encourage FDI-embedded technology transfer to local firms.

In addition to his participation at the forum, Philip met with Vietnam's Deputy Prime Minister Voong Dinh Hue where he shared that Deloitte has established an auditing training centre in Vietnam.
