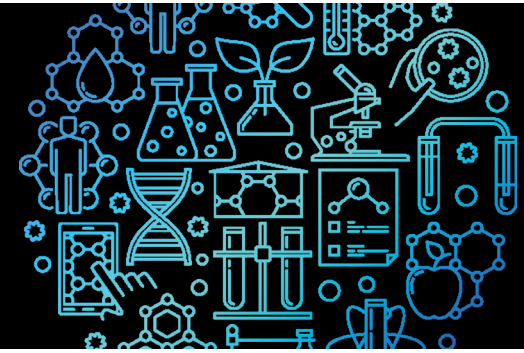

State-Based Marketplaces (SBMs) vs. the Federally Facilitated Marketplace (FFM)

As part of the Affordable Care Act, passed in March 2010, two public health insurance marketplace options were established for consumers to purchase health insurance: the **FFM** and the **SBMs**.

FFM

In a Federally Facilitated Marketplace, consumers apply for and enroll in coverage through Healthcare.gov.



SBM

States running an SBM are responsible for performing all marketplace functions for the individual market. Consumers in these states apply for and enroll in coverage through marketplace websites established and maintained by the states.

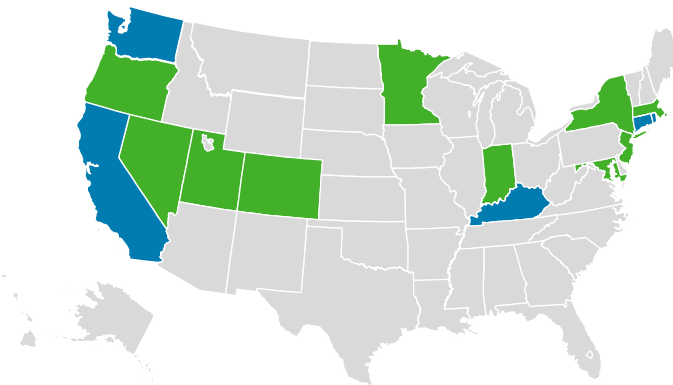
