THE ISSUE

As a rapidly growing business, Compass Group needed more effective cost and quality controls in facilities management to prevent unauthorized purchases of non-food items, such as equipment and services, within operational units.

THE SOLUTION

Compass Group decided to implement an SAP-based workflow and procurement solution, and partnered with Keytree to create iApprove, an internet-based front-end.

Users can log in securely to create, review and approve purchase requests for approved suppliers. The system enables finance to match POs with invoices and deliveries.

Keytree installed and configured the SAP SRM functionality, configured SAP ECC 6.0 for POs, goods receiving, invoice entry, and built an approval workflow in SRM 7.0.

THE IMPACT
