### Pillar Two Agent

### Use Deloitte's Pillar Two Agent for:



#### Automated data collection:

Data can be collected automatically from your organization's enterprise resource planning (ERP), tax provision systems, or other company data systems using APIs where appropriate.



#### Manual data collection:

If data collection is less frequent or does not reside in your ERP system, it can be collected manually and added to the Pillar Two Agent.



#### Calculations:

Pillar Two Agent's calculation functionality includes an intuitive user interface, the ability to input data easily from around the world, a robust audit trail and workflow functionality, and the ability to add comments and files.



#### Reporting:

The Pillar Two Agent will provide analytics for review, as well as downloadable results into Excel. Use the dashboard for insights and decision making.



#### Filing:

Pillar Two Agent will be able to generate Excel and/or XML files for Deloitte teams to file or e-file the returns to the relevant tax authorities in time for the 2025 filing deadlines. The platform will support multiple types of Pillar Two filings, such as GloBE Information Return (GIR), and the qualified domestic minimum top-up tax (QDMTT).
