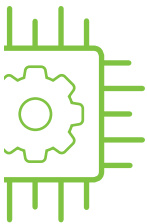

Today's tax departments are required to achieve more with less, while still facing challenges of multiple data sources, varying data quality, numerous processes, and country-specific requirements.

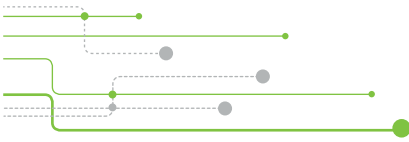
