### Introducing ISO 37301

**ISO 37301 is the new international standard on Compliance Management Systems (CMS), replacing ISO 19600.** ISO 37301 is centred on building a positive compliance culture with embedded compliance activities and regular training and communication at all levels of an organisation. ISO 37301 covers, among other things:

### New developments

#### Certification

The language is now directive rather than guidance with “shall” used to indicate certifiable requirements. Regulators, independent experts, judges etc. may use the standard in assessing an organisation’s CMS.

#### Conduct

The importance of a common standard of behaviour and conduct throughout the organisation to create and support positive compliance is highlighted. Top management is required to prevent and not tolerate behaviour that compromises compliance.

#### Compliance Ecosystem

There is an emphasis on the inter-related elements to manage compliance and that compliance management is a cycle of continuous improvement.

#### Organisational Context

The importance of organisational structure and an organisation’s broader social and economic impact is recognised as fundamental when building a CMS.

- ✓ Certification enables organisations to demonstrate, to customers, business partners and regulators that its practices, processes, structures and systems align to globally accepted standards, thereby confirming that the organisation is transparent and in compliance with its obligations.

- ✓ Leveraging alignment with regulatory obligations and ISO requirements.
