I advise that we, Timothy Norman, Salvatore Algeri and Eddie Senatore, were appointed Joint and Several Provisional Liquidators of the Companies on 9 June 2017 pursuant to an Order of the Supreme Court of NSW (the "Court") following an application made by the Deputy Commissioner of Taxation. **Enclosed** is a copy of the Court Order for your reference.

The winding up application has been listed to be heard by the Court on 3 July 2017.

As Provisional Liquidators, our role is to secure the Companies' assets and investigate their affairs. The Companies records have been seized by the Australian Federal Police (AFP). We will have more information once we have met with the AFP. Please refer to our website www.deloitte.com/au/plutus for further updates.

In the meantime, I note that we are unable to make any payments to employees during the provisional liquidation period however in order to assist with our investigations, employees are able to submit a claim by completing and returning the enclosed Proof of Debt Form (Form 536) to this office.
