

THE COURT: Good afternoon. This is Judge Lane.

We're here for a telephonic hearing in the United States

Bankruptcy Court for the Southern District of New York for the
4 o'clock calendar, which is on for a recognition hearing in
the Chapter 15 case, Virgin Australia Holdings Limited, case
number 20-11024.

The Court has been holding quite a few telephonic hearings over these last couple of months, and so I'll start with a couple of sort of tips of things that we've learned over those months, which is, one, is that sometimes people are on mute because we're all sharing workspace, and that's perfectly fine and appropriate. Just make sure to doublecheck before you speak that you unmute yourself, unless you may give an impassioned and eloquent speech on behalf of your client and not be heard.

Secondly, I will do my best to pass the figurative speaking microphone to each party in turn just to avoid the problem of -- as much as we can, of talking over one another.

And certainly, if you expect to hear from somebody who's either a client or a member of your team, feel free to do the same just so we can have an orderly presentation as possible.

And last, but not least, in this time of COVID-19, I hope all of you and your families are safe and sound, and I appreciate all of your cooperation in connection with holding

1	these hearings telephonically rather than in our normal way in
2	person. Again, telephonic seems to be working reasonably well
3	using Court Solutions, but it's not perfect, and it works as
4	well as folks really allow it to, and it's been working very
5	well, so thank you very much for your assistance and
6	cooperation in doing that and all the accommodations that are
7	involved with that.
8	So with all that, let me get appearances from counsel
9	for the foreign representatives of the foreign debtors in this
10	case.
11	MR. QURESHI: Good afternoon, Your Honor. This is
12	Abid Qureshi, Akin, Gump, Strauss, Hauer & Feld on behalf of
13	the foreign representatives of Virgin Australia Holdings. And
14	along with me today is my partner, Renee Dailey.
15	THE COURT: All right. Good afternoon. Is there
16	anyone else who is on the telephone who wishes to announce
17	their appearance at this time?
18	MR. WRIGHT: Yes, Your Honor. Derek Wright from Foley
19	& Lardner, on behalf of creditor, Airlines Reporting
20	Corporation.
21	THE COURT: All right. Good afternoon.
22	Anyone else who wishes to make an appearance?
23	All right. I see that those are all the folks who I
24	would expect to make an appearance based on the dashboard with

Court Solutions. I see there are a number of other parties who

25

are listen-only, and obviously that's perfectly fine.

But with that, I will turn it back over to counsel for the debtors to walk us through their request for recognition.

MR. QURESHI: Thank you very much, Your Honor. Again, for the record, Abid Qureshi of Akin Gump on behalf of the foreign representatives. And before I begin, if I could just confirm that the foreign representative and our declarant, Mr. Salvatore Algeri can hear me and that we can hear him? So if I could just ask Mr. Algeri to acknowledge that he can hear us clearly?

MR. ALGERI: Yes, I can hear you.

MR. QURESHI: Terrific. Okay. With that, Your Honor, if I may begin? Mr. Algeri is joining us on the line during his early morning, Friday morning in Melbourne. As Your Honor's aware from our papers, he is one of four foreign representatives that have been appointed by the Australian court in this matter.

Your Honor, first I would like to thank Your Honor and Your Honor's staff for hearing this matter telephonically. I certainly hope that we can soon be back at One Bowling Green to do this in person, but appreciate the Court working with us to do this telephonically and also to do so at this relatively late hour here, given the time zones with Australia.

I'd also like to thank the Office of the United States
Trustee. In advance of the filing of the verified petition and

the other pleadings, we did get a chance to run those by the U.S. Trustee's Office, which we, of course, appreciated.

As Your Honor will note, there have been no objections filed to the relief that we are seeking today. We did, yesterday, file an amended form of recognition ordered, together with the redline, indicating the changes, and I will explain to the Court what we did there. That was to resolve an issue raised by Mr. Wright's client, Airline Reporting Corporation, but we are pleased that we have an uncontested hearing.

I also want the Court to be aware that we have done everything, and more than we think we are required to do to ensure as broad a notice as possible of these proceedings. Your Honor, we served all of the papers on all of the known trade venders and employees in the United States on the trustees for the various bond issuances. And in addition to that, Deloitte, in their capacity as administrators for Virgin Australia, has a website with a specific page to which we post all of the Chapter 15 filings. And so this hearing today, and all of the pleadings, have, indeed, been widely publicized.

So, Your Honor, with that background, what I would propose to do, unless, of course, the Court would prefer to proceed differently, is to first provide a brief background on the voluntary administration proceedings in Australia and explain why we have sought Chapter 15 relief here in the United

1 States.

And, secondly, walk briefly through the requirements for recognition of a foreign main proceeding and why we believe those requirements have been satisfied here.

THE COURT: All right, that sounds fine with me, counsel. Please proceed.

MR. QURESHI: Thank you, Your Honor. Your Honor, the Virgin Australia Group owns and operates three domestic Australian Airlines, Virgin Australia, Virgin Australia Regional Airlines, and Tigerair, in addition to one international commercial airline, which is Virgin Australia International Airlines.

The Virgin Australia Group has a domestic market share in Australia of approximately thirty-eight percent, and before the onset of this crisis, Your Honor, they operated approximately 132 aircrafts.

Your Honor, there are a total of thirty-eight foreign debtors in these Chapter 15 proceedings. All of those debtors are incorporated in Australia. All of them have the same registered office, which is Virgin Australia's corporate headquarters in Brisbane, Australia.

It will come as no surprise to Your Honor that Virgin Australia, like pretty much every other airline in the world, has been severely impacted by the COVID-19 pandemic, which has had the result, unfortunately, of pretty much grinding its

operations to a virtual halt.

Since the quarantine and other stay-at-home orders in Australia and around the world, Virgin Australia's operations have been limited to flights that have been ordered by the Australian government in order to transport essential workers, to carry freight, and to help with the repatriation of Australian citizens who are abroad and who wish to return home.

Your Honor, prior to the COVID-19 pandemic, Virgin
Australia operated daily flights between Sydney, Australia and
its U.S. hub in Los Angeles, as well as multiple weekly flights
between Los Angeles and Melbourne. Since the onset of the
pandemic and since the commencement of the voluntary
administration proceedings in Australia, Virgin Australia has
continued to operate flights to Los Angeles, approximately one
flight a week between Brisbane and Los Angeles, as well as
between Melbourne and Los Angeles. And again, those flights
are presently for the limited purpose of repatriating
Australian citizens. In addition to that, Virgin Australia
continues to operate cargo-only flights between Australia and
LAX.

And, Your Honor, in addition to its flight operations in the U.S., Virgin Australia also has aircraft and aircraft parts service here in the United States. It currently has four of its leased aircraft at a maintenance facility in Nashville, Tennessee.

In addition, the foreign debtors maintain bank accounts in the United States. Out of a total workforce of approximately 10,000, the number of employees in the U.S. is minimal. It's only about eight. And as one would expect for an airline, there are numerous trade vendors in connection with its operations at LAX Airport.

Your Honor, with respect to its capital structure, the Virgin Australia Group has two significant funded debt obligations. One is a secured debt in aircraft finance facility in the approximate amount of \$2.25 billion Australian dollars, and in addition to that, unsecured note facilities totaling approximately \$2 billion Australian dollars. And it is those latter two unsecured notes issuances, which are both governed by New York law, and have the Bank of New York Mellon as the indenture trustee.

With that overview of the foreign debtors, Your Honor, I will next move to a brief overview of the proceedings in Australia. Your Honor, the boards of directors of each of the foreign debtors adopted resolutions concluding that each of the foreign debtors would or was likely become insolvent and should therefore appoint administrators.

There are four joint and several administrators that have been appointed, and those are Mr. Vaughan Strawbridge, Mr. Richard Hughes, Mr. John Greig, and our declarant, Mr. Salvatore Algeri.

Your Honor, the administrators were appointed on April
the 20th of this year and commenced the voluntary
administration shortly thereafter for all of the foreign
debtors, with the exception of one entity, which was not put
into administration until approximately one week later.

Your Honor, as we set forth in the verified petition, we provided general overview of the Australian Corporations Act and the insolvency procedures thereunder, as well as the duties of the administrators under that act. I don't intend, unless Your Honor has any questions, to go through any of that detail here, other than to note that the Australian Federal Court in Sydney, where these voluntary administration proceedings are pending, has general supervisory jurisdiction over the voluntary administration.

Your Honor, copies of the instruments of appointment of the administrators, as well as reports evidencing the commencement of the Australian proceedings, were attached to the verified petition that we filed and also referred to in Mr. Algeri's declaration.

Your Honor, the commencement of the voluntary administration proceedings in Australia did result in an automatic moratorium on the rights of creditors up to, among other things, take any action or continue any suits against the foreign debtors or their properties.

Your Honor, in light of the significant amount of New

York law governed debt, in addition to the ongoing operations that I've described here in the United States, the administrators determined that it would be wise to file a Chapter 15 petition, which we did on April the 29th, in order, principally, to have the benefit of the automatic stay while the administrators work through the process in Australia, which I will later describe in a little more detail.

Your Honor, where things currently stand is that the administrators have convened the first meeting of creditors, which is an initial step in an Australian voluntary administration proceedings. And at that meeting, a body called a committee of inspection was formed. That consists of thirty-five creditor representatives, including unions, secured creditors, trade creditors, bondholders, as well as the Bank of New York in its capacity as trustee.

Your Honor, the administrators, together with their financial advisors at Houlihan Lokey and Morgan Stanley, and their Australian counsel at Clayton Utz, have commenced a well-publicized sale process for the Virgin Australia Group. A data room has been established. Many interested parties have engaged with the administrators and their advisors. And the administrators have proposed a sale time table that contemplates binding offers being submitted by June the 12th, though that deadline is subject to being moved based upon the circumstances in Australia.

So, Your Honor, I'm happy, of course, to take questions at any point as to the status of things in Australia, but with that overview, I intended next to move onto the requirements for recognition and why we believe they are satisfied here.

THE COURT: All right. I don't have any questions at this point, and I certainly, having had the privilege of presiding over a few airline cases here in the U.S., and one in Chapter 15, can understand the amount of stress that COVID-19 would place on an entity like these entities, and I guess also a couple of the Australian fires that took place earlier in the year. So with that, I think we can turn to recognition.

MR. QURESHI: Great. Thank you, Your Honor. Your Honor, it is obviously important to the administrators and, indeed, to the government of Australia, on whose behalf Virgin Australia is currently operating its flights to the U.S., that they avoid any disruption that would be caused by any creditors that might seek to take action in the U.S.

So turning first to Bankruptcy Code Section 109(a), which courts in this district have applied to determine eligibility to commence a Chapter 15 petition, we think the Virgin Australia Group clearly satisfies the requirement of having sufficient property in the United States. I've described the intangible property in the form of the bond issuances, in addition to the bank accounts and the aircraft.

And, Your Honor, we cite the case law at pages 13 through 15 of the verified petition, but I think there are certainly more than sufficient connections to the United States to make the Virgin Australia Group proper Chapter 15 debtors.

And so with that, Your Honor, I turn next to

Bankruptcy Code Section 1517, and why we believed that the

proceedings in Australia meet the bankruptcy code definition of

being a foreign main proceeding.

And again, Your Honor, the -- we go through the case law at some length in the verified petition. But, Your Honor, we don't think there's any doubt here that Australia is the center of main interests under Bankruptcy Code Section 1502(4) for a number of reasons.

First, the corporate headquarters of Virgin Australia Group, as I mentioned, are in Brisbane. Australia is the place of incorporation of all of the Chapter 15 debtors. It is where decision-making is controlled from. It is the principle place of business of these debtors. It is the site of a majority of their assets, and it is also the location where the principle administrative functions, such as accounting and financial reporting and the like are conducted from.

Finally, Your Honor, the Chapter 15 proceedings have been commenced by a duly authorized foreign representative as required by Section 1517 of the Bankruptcy Code. As set forth in Mr. Algeri's declaration, the administrators were duly

appointed by board resolutions and subsequently empowered by the Australian Corporations Act to take control over the foreign debtors' businesses, property, and assets. Your Honor has certified copies of the relevant administrative papers that commence these proceedings, as well.

And of course, lastly, and I don't think I need to dwell on this, there is no public policy reason in the United States that would counsel against recognition of an Australian proceeding. As Your Honor will see from the details in the verified petition, the duties of the voluntary administrators and the general nature in which those proceedings are run is, in many crucial respects, not that different from our own bankruptcy regime here in the United States.

So with that, Your Honor, I wanted to turn briefly to the amended order that we filed on the docket yesterday. And, Your Honor, if I could refer -- it's docket number 11 for the record, and I think it might be easiest to refer to the redline that we attached, which is at page 11 of 16 of the --

THE COURT: I have that -- I have that in front of me, counsel. Thank you very much.

MR. QURESHI: Thank you, Your Honor. So the redline contains a number of what I would simply describe as cleanup and typographical changes. I think the only substantive change is in paragraph 9, which appears on page 14 of 16 of the redline. And as Your Honor will see, this paragraph was added

to resolve an issue that was raised by Mr. Wright's client, the Airlines Reporting Corporation. I will describe briefly what we are trying to achieve with this language, and Mr. Wright will no doubt correct me should I get any of it wrong.

Your Honor, at a general level, his client, ARC, processes bookings for Virgin Australia made with travel agents here in the United States. So ARC and Virgin Australia are signatories to a carrier services agreement. It was important to Virgin Australia that the foreign debtors continue to have access to the ARC system and continued to be able to settle transactions with U.S. travel agents during the pendency of these Chapter 15 proceedings.

So what this additional paragraph makes clear, Your Honor, is that the foreign debtors will continue to reimburse ARC for any ticket refunds that are issued and processed by ARC, as Your Honor would imagine the volume of refunds, given the cessation of regular operations, is quite large.

And that ARC shall not be permitted to set off any post-administration amounts owing by Virgin Australia to ARC against any post-petition payables from the foreign debtors to ARC, or against any amounts that are held by ARC as collateral.

Your Honor, from the foreign debtors' perspective, this provision is important in that it makes clear that ARC shall not suspend Virgin Australia from the ARC system or require the posting of any further collateral as a result of

the voluntary administration or of these Chapter 15 proceedings 1 before first seeking authority to do so from this Court. 2 So with that, Your Honor, why don't I just pause 3 4 quickly and see if Mr. Wright has anything to add with respect to the additional paragraph in the proposed order? 5 MR. WRIGHT: Thank you. This is Derek Wright, Your 6 7 Honor, on behalf of Airlines Reporting Corporation. That was an accurate -- an accurate summary of the purpose and the 8 resulting language. This was -- you know, we've done this in 9 10 previous cases out of an -- out of an abundance of caution to 11 ensure that both parties can continue operating. 12 Under the Carrier Services Agreement in the ordinary 13 course of business, both sides put certain protections in here so that we believe there's no issue with the automatic stay or 14 15 otherwise, and that's clear, but it just provides that all rights are protected to continue operating under the agreement 16 17 in the ordinary course. 18 THE COURT: All right, thank you very much. 19 MR. WRIGHT: Thank you. THE COURT: Anything else from Debtor's counsel in 20 21 support of recognition? 22 MR. QURESHI: So, Your Honor, just one last administrative matter, which is just to -- I would like to move 23 24 into evidence for purposes of this recognition hearing, Mr. 25 Algeri's declaration. He is on the line and, of course,

available to answer any questions that the Court or any other
parties-in-interest may have.

THE COURT: All right. Any party wish to be heard in
connection with that request to receive that declaration, which
is Docket Number 3?

All right. I'm happy to receive it, and I appreciate Mr. Algeri dialing in from his side of the world, given the time difference, and I was happy to accommodate as a hearing for 4 o'clock to make it possible that -- for him to attend. So that is received into evidence.

(Mr. Algeri's declaration was hereby received into evidence as Debtor's Exhibit 3, as of this date.)

MR. QURESHI: Terrific.

THE COURT: Anything else, counsel?

MR. QURESHI: So Your Honor, other than to point out, Your Honor, that we, again, think that requirements for recognition of the Australian proceedings as a foreign main proceeding are satisfied here. Your Honor, in light of the ongoing sale process in Australia, it is not entirely clear when, and in exactly what form we may need to come back to this court for further relief.

And so assuming Your Honor is inclined to grant the relief we seek today, I would propose that we, at the Court's pleasure, either schedule a status conference for maybe four weeks out or, if the Court would prefer, we could also simply

file a written status report on the docket, as well.

THE COURT: All right. Thank you.

All right. So let me attend to first things first, I am happy to grant recognition here. I wholeheartedly agree that the requirements for recognition are satisfied here and are in fact satisfied easily. The debtors are eligible for Chapter 15 relief. They satisfied Section 109(a) as that has been interpreted by the Second Circuit here with both the indentures as well as the bank accounts, aircraft, and equipment.

And moving on to the main event, the Australian proceedings should be recognized as foreign main proceedings. They are, in fact, foreign proceedings under the statute an applicable case law. They also qualify as foreign main proceedings, given everything in the record here. They have been commenced by a duly authorized foreign representative, and they also satisfy the more technical requirements of Bankruptcy Code Section 1515.

And finally, I can easily conclude that recognition here is not contrary to U.S. public policy, which is, in fact, a fairly high hurdle to serve as a disqualifying factor, but it is not even implicated here.

I also find that the proposed form of order is appropriate, including the additional paragraph that's been provided and was filed on the docket in advanced to today's

hearing, and I appreciate counsel filing that early. It gives me a chance to take a look at these things, so thank you so much.

And so again, I know these orders traditionally go
through the -- all the requirements for recognition, but since
the Court has an independent duty to assess these, even in the
absence of an objection, I always like to put at least an
abbreviated version of the requirements and how they're
satisfied on the record, but I won't belabor the point, given
all the facts and circumstances here.

So -- and last, but not least is the schedule. We're happy to schedule something, save you from having to write a written status report. It usually seems that the status conference is preferable. But so what I would just suggest in the COVID-19 environment, the -- so the simplest way to do this is just to email my chambers and my courtroom deputy, Liza Ebanks, will be in touch about getting you the date that you need. And if for some reason you think it's preferable to submit a status report, you can let us know that, as well, but certainly I'm happy to give you a date if that's your preferred method of touching base.

MR. QURESHI: Thank you, Your Honor. I think that is our preferred method. I will remain optimistic and hope that in approximately four weeks' time, we can be back at One Bowling Green, but if not, we will certainly be pleased to do

it by phone again.

THE COURT: All right. Yeah, and I think, at least speaking for myself, I recognize this is a rapidly changing environment and we seem to get additional guidance or thoughts about what's happening in this country on a fairly regularly basis, and they're sometimes not always on the same page, but particularly given New York's -- how central it's been to COVID-19, I don't anticipate we're going to reopen for regular business anytime soon.

To the extent that any party needs something that's evidentiary, that's really going to be, I think, the thing where we're going to put our heads together to figure out how to do that, although I know at least one of my colleagues in this court, has done an evidentiary hearing remotely and that has been successful, so I just pass that along just to the bar for sort of future reference in this case and other cases that you may be working on. But certainly, in terms of hearings that we can handle telephonically, until there's, I think, maybe a little more guidance or wisdom or significant changes, I think we're going to be doing -- contemplating doing things telephonically.

So -- but again, we're here for whatever you need, and if you have some unusual issues that come up that may be -- you have suggestions about ways to tweak procedures, I'm certainly happy to hear it and we'll figure it out as the need arises.

1	MR. QURESHI: Well, thank you very much, Your Honor.
2	We certainly appreciate the Court's flexibility.
3	THE COURT: All right. With recognition concluded,
4	anything else that we need to address here this afternoon?
5	MR. QURESHI: Nothing further from the foreign
6	representatives, Your Honor.
7	THE COURT: All right. Thank you.
8	Anything further from any other party?
9	All right, hearing nothing further, the Court is
10	adjourned, and I'll so order the record to the extent that
11	that's helpful, but obviously, what I would ask is just email
12	us, to the extent you haven't already, a copy of the latest
13	version of the order. That's a little easier to work with the
14	format, rather than trying to pull it off the docket the PD
15	off the docket, so we'll get that entered shortly.
16	MR. QURESHI: We will do so immediately. Thank you,
17	Your Honor.
18	THE COURT: Thank you very much. Have a good day and
19	stay safe, all.
20	MR. QURESHI: Likewise. Thank you.
21	MR. WRIGHT: Thank you.
22	(Whereupon these proceedings were concluded at 4:35 PM)
