- I refer to Schedule 1 of the Originating Process filed in these proceedings and adopt the 3. defined terms contained therein.
- The following facts are within my own personal knowledge except as otherwise stated. 4.
- In late 2012 IMF was approached by a creditor of RAPL and asked to consider funding legal 5. actions against officers and others connected with RAPL.

- On 13 February 2013 IMF sent a letter of introduction to certain creditors of RAPL. Exhibited at pages 1 - 3 is a copy of that letter.
- On 19 March 2013 IMF announced that it proposed to fund an investigation, public examinations and legal proceedings to recover losses incurred by unsecured creditors of RAPL. Exhibited at page 4 is a copy of the announcement to the ASX dated 19 March 2013.
- 8. On 18 March 2013 an information pack was emailed to 78 creditors of RAPL. Exhibited at pages 5 62 is a copy of the list of creditors that the information pack was email to and a copy of the information pack.
- 9. On 20 March 2013 an information pack was mailed to a further 526 creditors of RAPL. Exhibited at pages 63 72 is a copy of the list of the creditors to whom the information pack was mailed to. Two further mail outs of the Information pack occurred on 20 March 2013 and 23 March 2013. A further 38 creditors of RAPL received the information pack shortly after this. Exhibited at pages 73 74 is a copy of the two supplementary lists of creditors the information pack was mailed out to.
- 10. Between 20 March 2013 and 2 September 2013 128 RAPL creditors executed and returned IMF Funding Agreements. Based on the adjudication of the informal proofs of debt by the administrators of RAPL the value of the debts owed to those creditors was \$28,026,324. Exhibited at page 75 is a schedule of the Funded Creditors as at 2 September 2013 (List of Funded Creditors).
- On 26 August 2013 IMF sent out a notice to all Funded Creditors attaching a revised funding agreement. The amended IMF funding agreement incorporated the requirements of IMF's conflict management policy. Exhibited at pages 76 108 is a copy of the revised IMF funding agreement in mark up.
- 12. Since 2 September 2013 the List of Funded Creditors has been amended for the following reasons:
 - (a) IMF discovered that one of the creditors, Ice Water Press Pty Ltd (Receivers and Managers Appointed), was under the control of a receiver and manager at the time that it executed the funding agreement with IMF. The IMF Funding Agreement was executed by the director of that creditor company without the authority of the receiver. As a result that creditor is no longer part of the IMF funded creditors.
 - (b) Gummie Pty Ltd assigned its debt to Group Security Solutions Pty Limited. Exhibited at pages 109 - 112 is a copy of the Formal Proof of Assigned Debt; and
