OPENING OF THE MEETING

Mr Jason Tracy, a Joint and Several Administrator of the Companies, opened the meeting at 9:02AM AWST (12:02PM AEDT).

CHAIRPERSON

Mr Tracy introduced himself as one of the four (4) Joint and Several Administrators of the Companies and advised that he would act as Chairperson of the meeting in accordance with rule 75-50 of the *Insolvency Practice Rules (Corporations) 2016* (**IPR**).

INTRODUCTION BY CHAIRPERSON

The Chairperson Tracy introduced:

- Sal Algeri, his fellow Joint and Several Administrator who was present;
- Samantha Kinsey of King & Wood Mallesons, legal counsel for the Administrators who was also present;
- David Orr and Glen Kanevsky, his fellow Joint and Several Administrators in attendance virtually; and
- advised that other members of Deloitte staff engaged on the Voluntary Administrations were also in attendance in person and virtually.

MEDIA

The Chairperson asked that any members of the media who were not creditors of the Companies exit the meeting, and the Administrators would be willing to provide a media briefing after the creditors meeting.

THE COMPANIES SUBJECT TO EXTERNAL ADMINISTRATION

The Chairperson referred to the listing of 12 entities which were displayed on screen at the meeting and advised this was the first meeting of creditors for the 12 entities subject to Administration. He advised that he would refer to the group of 12 entities as the **Clough Group** throughout the meeting. A copy of the schedule of 12 entities is attached at **Schedule A**.

CONCURRENT MEETINGS OF CREDITORS

The Chairperson advised that the meetings for the Clough Group would be held concurrently, as indicated by the Notice of the First Meetings of Creditors dated 7 December 2022, the meeting having been advertised in the Australian Securities

and Investments Commission (**ASIC**) Insolvency Notices web site https://insolvencynotices.asic.gov.au on 7 December 2022. The Chairperson advised there had been no objections or concerns raised by creditors to the meetings being held concurrently.

The Chairperson asked that any objections to the meetings being held concurrently be raised in writing to cloughVA@deloitte.com.au.

VIRTUAL MEETINGS

The Chairperson advised that due to COVID-19 and consistent with Government policy on gatherings, the Administrators are unable to conduct a meeting of this size and significance at a physical venue. Additionally, given the geographic spread of creditors it would be inappropriate to convene a physical meeting. Amendments to the legislation that govern insolvent administrations provides that meetings of creditors may be held virtually, using technology such as Microsoft Teams and the Deloitte Halo platform, that gives all persons entitled to attend a reasonable opportunity to participate and vote at the meeting without being physically present in the same place.

The Chairperson advised that in order to facilitate attendance at the meeting the Microsoft Teams Live Events platform was utilised, and the meeting was conducted within the guidelines established by the ASIC for holding virtual meetings.

ATTENDANCE REGISTER

The Chairperson advised numerous registrations for attendees and observers of the meeting had been received.

The Chairperson noted that given the significant number of registrations received, it was impractical to read those who were in attendance out to the meeting.

The Chairperson noted that those creditors and observers who registered to access the meeting webcast would be recorded on the attendance registers (refer to the **Annexures A & B**).

The Chairperson noted that observers were unable to participate in the creditor meeting by asking questions.

QUORUM

The Chairperson declared a quorum present pursuant to Section 75-105 of the IPR and Regulation 5.6.16 of *the Corporations Act 2001* (Cth) (the **Act**) for each of the companies in the Clough Group.

RECORDING OF MEETING

The Chairperson noted that there will be an audio recording of the meeting to allow for accurate minute taking for reporting to the ASIC. The Chairperson advised that any objections to the meeting being recorded are to be raised in writing to cloughVA@deloitte.com.au.

TABLING OF DOCUMENTS

The Chairperson tabled the following documents:

- Notice of the Meeting of Creditors dated 7 December 2022
- Advertisement on the ASIC Insolvency Notices website dated 7 December 2022
- The Declaration of Independence, Relevant Relationships and Indemnities dated 6 December 2022

The Chairperson noted creditors had no objections to the tabling of these documents and assumed that the tabled documents as being read by creditors. He advised that usually copies of the documents would be available at the meeting, however, given the meeting was virtual, these documents would be available on the website at https://aurestructuring.deloitte-halo.com/Clough/.

NOTICE OF MEETING

The Chairperson advised that the meeting had been called in accordance with the Notice of the First Meeting of Creditors dated 7 December 2022, which was distributed to creditors as an enclosure to the *Initial Notice* to *Creditors* (**Initial Notice**)

dated the same date. The Notice of the First Meeting of Creditors was advertised on ASIC's Published Notices Website on 7 December 2022, available at https://insolvencynotices.asic.gov.au/.

DECLARATION OF CONVENIENCE

The Chairperson stated he had not received any objections to the time and place of the meeting. Therefore, pursuant to 75-30 of the IPR, he declared that the meeting was held at a time and place most convenient for the majority of persons entitled to receive the notice of meeting.

PROXIES

The Chairperson advised the Administrators had received numerous proxies for creditors of the Clough Group for which the concurrent meeting was held.

Given the significant number of proxies received, it was impractical for these to be read out to the meeting.

The Chairperson noted that general proxies would not be exercised in favour of any resolutions which would financially affect the Administrators, the partners, or the firm.

AGENDA

The Chairperson outlined the agenda for the meeting as follows:

- 1. Purpose of Administration
- 2. Update on Administration
 - Orders made by the Federal Court on 13 December 2022
 - Role of the Administrators
 - Action since appointment
 - Sale and / or recapitalisation of the business
- 3. Questions
- 4. Committee of Inspection nominations and voting
- 5. Closure

The Chairperson advised that following an update on the Administration, creditors would have the opportunity to ask questions. The meeting would then be placed on hold, whilst the creditors vote to resolve the Clough Group's Committee of Inspection (**COI**), as detailed in the Initial Notice.

PURPOSE OF ADMINISTRATION

The Chairperson provided a brief explanation of the purpose and process of voluntary administration, noting the purpose of a voluntary administration was to maximise the chances of a business continuing in existence or, if this was not achievable, providing for a better return to creditors.

The Chairperson advised the appointment of the Administrators was made by the directors of each of the Companies.

The Chairperson informed the meeting of the role and obligations of an Administrator enshrined in Sections 437A and 438A of the Act.

The Chairperson outlined that the primary function of an Administration was to assume control of the affairs of the Companies while the Administrators conduct investigations into the affairs of the Companies, as soon as practicable, and forms an opinion as to whether:

- 1. the Companies should enter into a Deed of Company Arrangement;
- 2. the Administrations should end, and control of the Companies be returned to the directors; or
- 3. the Administrations should end, and the Companies be wound up in insolvency.

The Chairperson also noted that the Administrators could also sell the business and assets of a company.

UPDATE ON THE ADMINISTRATION

The Chairperson provided an update on the Administration of the Companies regarding:

Court Orders

The Chairperson provided the following summary regarding Orders obtained in the Federal Court of Australia to date.

Timeline of the voluntary administration

The Chairperson provided a summary of the timeline of the Voluntary Administration process and elaborated on its key milestones.

The Chairperson outlined that the Voluntary Administration process has five distinct phases:

- 1. Appointment: assume responsibility of the Companies, undertake a financial assessment and facilitate continued trade on commercially viable active projects;
- 2. First creditors meeting: creditors can decide to replace the Administrators and / or create a COI;
- 3. Investigation period: investigate the causes of failure and financial position of the Companies with the purpose of reporting the findings to creditors;
- 4. Second creditors meeting: where the outcome of our investigations are discussed and the future of the Companies will be decided upon; and
- 5. Finally, we implement what is agreed by creditors at that second meeting of creditors.

The Chairperson outlined that after the first meeting of creditors, the Administrators would proceed with their investigations into the Companies' financial affairs and report to creditors on the Companies' business, property, financial circumstances, and vote on the future of the Companies at the second meeting of creditors.

The Chairperson noted that the Administrators' current strategy was to trade as much of the business as possible while seeking a sale and restructure of the business. The Chairperson further noted that as Administrators, they had the ability to

sell the business and assets at any time. This might occur prior to the second meeting, however if the sale was to be completed by way of a Deed of Company Arrangement (**DOCA**), this would be presented to creditors at the second meeting for consideration by creditors, together with the Administrators' recommendation as to whether the DOCA was in the best interest of creditors, as opposed to other options available.

The Chairperson advised that prior to the second meeting of creditors, the Administrators would report to creditors on the findings of their investigations, although acknowledged these might be continuing. This was so all creditors could make an informed decision about the future of the companies.

At the second meeting, creditors would be asked to resolve or vote on one of the following potential outcomes:

- 1. The Companies enter into a DOCA; if one was put forward;
- 2. The Administrations end and control of the Companies be returned to the directors; or
- 3. The Administrations end and the Companies be wound up.

The Chairperson outlined that the Administrators would provide professional opinions to assist as to which alternative the creditors should vote and the reasons why. Further, the Administrators' report would also set out the likely return to each class of creditors.

The Chairperson outlined the intention to seek the following Court Orders next week:

- an extension of the convening period for one month; and
- leave to allow the members of the COI to derive profit and take advantage from the external administrations of the Clough Group.

The Chairperson explained that an Application to extend the convening period was a common request in voluntary administrations involving large and complex businesses, and further, taking into account the size and nature of the Companies' operations and the Administrators' intentions to achieve a sale and restructure of the Companies, the extension would allow the Administrators necessary time to undertake the restructuring of the Companies.

The Chairperson further noted that it was the Administrators' intention to consult with the COI in relation to any Application to Court and asked that any creditors who had any concerns with such an Application raise this in writing addressed to: cloughVA@deloitte.com.au.

Corporate structure

The Chairperson passed over to his joint Administrator, Mr Sal Algeri to talk to the corporate structure of the Clough Group.

Mr Algeri displayed on screen the Clough Group's domestic corporate structure on and provided a high-level summary of the major trading entities and respective trading activities relative to the wider Group structure. He advised the meeting that:

- the Australian registered parent company was Murray & Roberts Pty Ltd
- 24 controlled Australian entities formed the Clough Group at the date of Administration
- the main employing entities were (denoted by a blue dot on the screen):
 - o Clough Projects Pty Ltd
 - o E2o Pty Ltd
 - Sharp Resources Pty Lt
- the ultimate parent company, Murray and Roberts Holdings Limited was based in South Africa and listed on the Johannesburg Stock Exchange but not subject to our appointment
- all entities listed on the slide and shaded in light blue were not subject to the Voluntary Administration.

Projects status

Mr Algeri displayed on screen a map summarising the major active projects of the Clough Group as at the date of the meeting. He provided a high-level summary of each of the projects, talking to the following points:

Snowy 2.0

Snowy Hydro 2.0 is a renewable hydropower energy project to link two existing dams in NSW

 Webuild along with The Lane are Clough's JV partners with the ultimate client being the Commonwealth owned Snowy Hydro Limited.

EnergyConnect - Secure Energy JV

- EnergyConnect involves the delivery of four substations and 700km of high voltage transmission lines extending from Wagga Wagga (NSW) to Robertson (SA) and a connection to Red Cliffs (VIC)
- Clough's JV partner is Elecnor. The ultimate client is Transgrid.

Waitsia Gas

- Waitsia Gas is an EPC (Engineering Procurement and Construction) project for the Stage 2 development of liquid natural gas facility located in Dongara 3-4 hours North of Perth
- Clough's clients are Mitsui and Beach Energy.

Lombrum Naval Base

- Refurbishment and rebuild of port infrastructure at the Lombrum Naval Base on Manus Island (PNG)
- Clough's client is the Department of Defence.

Tallawarra – consortium agreement (50%)

- Tallawarra Power Plant is an EPC (Engineering Procurement and Construction) project for the Australia's first net zero emissions hydrogen and gas capable power station in Yallah near Wollongong (NSW)
- Clough has partnered with GE in a consortium for this project
- Clough's client is Energy Australia.

Stephenson Avenue extension

- Delivery of the road extension project north of Perth CBD (WA) to connect each side of the Mitchell freeway, including a new bridge, removal of on/off ramps and new on-street parking and upgrades
- Clough is completing this project in an alliance with Acciona and WSP for Main Roads Western Australia.

Lihir Goldmine shutdown maintenance

- Cost reimbursement contract to conduct shutdown scope at Newcrest's Gold Mine on Lihir Island (PNG)
- Includes planned maintenance, corrective and project improvement works.

Employee entitlements

Mr Algeri advised that employee entitlement calculations had been made for annual leave and long service leave based on reports and information provided by Clough. He reiterated that the entitlement calculations were estimates only at this stage. He advised that an estimated \$12,150,997 was owed to 1,192 employees across the Group.

The Chairperson noted that employees' entitlement balances would be updated throughout the course of the Voluntary Administration and advised it was the Administrators' hope the majority of these entitlements would be transferred in due course with the preservation of jobs for as many as people as possible.

Short term liquidity and business continuity

The Chairperson provided an update with respect to the ongoing trade of the Clough Group. He advised that to provide liquidity to facilitate ongoing trade, the Administrators entered into immediate discussions with clients, JV and alliance partners, and Principals in respect to covering the ongoing employee, on-costs and overhead costs associated with the Clough Groups' operations. He advised that during the first week of the Administration, the Administrators were successful in securing funding across 95% of the business in respect to outstanding wages and on-costs accrued to the 5 December 2022, and then in the majority of cases, weekly in advance.

In respect to those contracts where Clough was directly responsible for meeting subcontractor material and supplier payments (Waitsia and Tallawarra) he advised that the Administrators had also secured funding from the Principals to meet those costs on a week-to-week basis. In effect, the monies provided by the clients, JV and alliance partners, and Principals was held by the Administrators for the benefit of employees, meeting overhead expenses and meeting subcontractor expense claims.

He noted that these arrangements were critical for Clough's short-term survival and preserving in excess of ~1200 direct employees and thousands of other subcontractor employees and facilitating payments to employees, subcontractors and suppliers.

The Chairperson advised that as a consequence of these payments the Administrators had been able to facilitate the following:

- Payroll run for Waitsia in the first week blue collar of c. \$557K;
- Payroll run for Tallawarra in the first week blue collar of c. \$92K;
- The monthly payroll process for all white collar employees yesterday of c. \$11M;
- Direct payments to subcontractors and suppliers totalling c. \$14M; and
- Processes to facilitate the transfer of monies from JV bank accounts to subcontractors and suppliers, which continue business as usual for Snowy Hydro and Project EnergyConnect.

Actions to date

The Chairperson then briefly outlined the main actions taken by the Administrators since their appointment, including:

Statutory compliance

- Attending to ASIC filings and statutory tasks
- Convening first meeting of creditors
- Notices to creditors and employees

Employees & Unions

- Meetings with employees and unions
- Holding employee townhalls
- Processing payroll
- Preliminary calculation of employee entitlements

Administration

- Setting up a creditor claims database for ongoing management with creditors
- Establish three (3) mailboxes which have received over 673 emails from creditors and stakeholders to date.

Business operations

- Majority of time has been spent negotiating and putting in place arrangements to stabilise the businesses operations to preserve jobs and value for a restructure
- Reviewing commercial viability of current projects and preparation of cash flow forecasts and budgets to understand cost to complete

Assets

- Insuring assets
- Maintaining and securing sites

Secured creditors

- Meetings with secured creditors
- Preliminary calculation of secured debts
- Negotiations with secured parties regarding continued use of secured assets

Surety Holders

 Meeting and liaising with surety holders regarding Administration and arrangements regarding their security on active projects

Other unsecured creditors

- Liaising with unsecured creditors regarding the Administration
- Processing Proof of Debt and Proxy forms

Government

- Liaising with State and Federal Government entities and their representatives regarding the Administration, including the relevant building licensing agencies

Landlords

- Discussions with landlords regarding the Administration

Stakeholders

Liaising with all other stakeholders regarding the Administration

Sale and business recapitalisation

The Chairperson provided an update with respect to the sale and business recapitalisation. He advised that late on 13 December 2022, the Administrators entered into an agreement with Webuild in respect of the acquisition of Clough's Australian business and projects, including its share of the Snowy 2.0 and the Inland Rail contracts in which Clough is Webuild's partner.

He provided the following high-level summary:

- Exclusivity to reach a final agreement until midnight, 21 December 2022;
- Webuild have already conducted extensive due diligence and therefore were the obvious suitor. The Administrators understood that Webuild withdrew from the prior sale discussions due to concerns of being exposed to significant potential losses on certain projects, including the US Traveller project;
- The Administration provides an opportunity to exclude the US based Traveller Project and renegotiate with certain clients and Principals on a potential way forward on other projects;
- The next week will be important for all parties as the Administrators pursue a successful outcome and provide certainty; and
- It is the Administrators' intention where unable to achieve sales of contracts, to work with the relevant stakeholders to achieve an orderly handover of those projects.

Proposed Committee of Inspection

The Chairperson advised that as creditors would recall from the Administrators' Initial Notice dated 7 December 2022, creditors may resolve to appoint a COI at this meeting.

The Chairperson outlined that the role of the COI was to consult with the Voluntary Administrators about matters relevant to the Voluntary Administration and to receive and consider reports from the Voluntary Administrators. The members of the COI might also require the Voluntary Administrators to report to them about the Voluntary Administration and approve the Voluntary Administrators' fees.

The Chairperson made creditors aware that members of the COI were not remunerated for their time.

The Chairperson reiterated that on 13 December 2022 the Federal Court of Australia granted Orders permitting the formation of a single COI to represent all companies in Voluntary Administration.

The Chairperson advised that the Administrators had received 8 COI nomination forms. Accordingly, the COI for the Clough Group may have 9 members (with FEG as an observer) which he considered sufficient to enable the COI to operate efficiently.

The Chairperson then put the following resolutions to the meeting:

"That a single committee of inspection of the companies in voluntary administration be formed and that the members will be those nominated and communicated by the Voluntary Administrators".

The Chairperson communicated to those in attendance that Green Light Contractors Pty Ltd had nominated Adam Nikitins and / or Peter Bowden as their representative on the COI. He noted the submission was made 40 minutes prior to the meeting commencing however would accommodate this nomination. He invited any creditor who may have concerns with this late nomination to express so in writing to cloughVA@deloitte.com.au.

The Chairperson advised that he would take a poll in respect of the proposed resolution and that creditors could vote using the Halo platform and he would announce the results.

The Chairperson took a short recess to allow time for creditors to vote.

The Chairperson then declared voting was now closed.

The Chairperson took a short recess to allow time for the votes to be counted.

The Chairperson advised the resolution was passed. The results of the resolution for the COI were as follows:

The Chairperson advised that the Q&Q function was now live, and creditors should submit their questions.

The Chairperson took time to address questions submitted prior to the meeting at the time of registration while questions were being submitted through the live meeting platform.

What can I do if I am owed money?

If you are owed money by the Companies, you are entitled to lodge a claim with the Administrators. Please see our first circular to creditors for details of how to lodge a claim using the Halo platform or access the link below:

When will creditors be provided with further updates?

Further updates for creditors will be made on the Halo platform and via email as appropriate.

We will also be providing creditors with a report which will provide details of our investigations and our opinion as to what creditors should resolve for the future for each of the Companies.

What is the estimated return to creditors?

At this stage, we are unable to provide an estimate of the potential return to creditors. The creditor position is moving over time. Several outstanding contractor claims have now been paid because of the funding we sought and was provided by Principals, JV and alliance partners, and clients, to support the ongoing trading of the business.

Why have I not received notification regarding the Voluntary Administration?

Once we are appointed as Voluntary Administrators, we take steps to secure the company records which include details of all known creditors. Unfortunately, some creditor details may not be provided in these records which is why we advertise our appointment with ASIC as required pursuant to the Corporations Act 2001.

If you are aware that you or any other creditor of the Companies have not received our emails regarding the Voluntary Administration, we would request that you email our team to provide your contact details and we will update our records accordingly.

How do employees make a claim for amounts owed?

At this stage, the employee entitlement details uploaded into Halo are for your information only and to provide you with the opportunity to review the balance of the entitlement. This is not a final determination of your employee entitlement balance and you will have a further opportunity to review your entitlement claim following the first meeting of creditors. The estimate of employee entitlements provided is at a point in time (being the date of appointment – 5 December 2022) and will increase or decrease during the Administration as leave is accrued or taken and the Administrators work through other required adjustments.

In the event the company which employed you is placed into liquidation, you may be entitled to make a claim pursuant to the Fair Entitlements Guarantee Scheme. Further information regarding this scheme will be provided to employees.

Can we get a copy of the minutes?

A copy of the minutes will be available via the Halo platform. In addition, we will provide a copy of the minutes to creditors who email us. The minutes will also be lodged with the ASIC, which we will endeavour to do so as soon as practicable.

Is there a reason Clough Projects Queensland is not in VA?

It is a decision of the directors of the Companies whether to place the company into Voluntary Administration. We suspect that this entity was not required to comprise the appointment as the company was not insolvent or at risk of becoming insolvent at the time of the appointment.

We are suppliers for the Waitsia project and have lodged a claim for the open orders. We are proceeding with the manufacturing (in good faith) as Clough is constantly chasing the status of the goods. Will the administrators arrange payments before delivery and communicate this in writing?

We encourage the supplier to reach out to Mitsui, Beach Energy and the Clough team. We are trying to ensure business as usual operations with the support of Principals and subcontractors. At this stage there is an ongoing commitment from Principals and clients to provide us with funding.

What happens to employee entitlements accrued prior to the VA if the employee resign now? Who will pay for the outstanding entitlements; will that be Webuild or other parties?

Employees have a priority claim over circulating assets (i.e. cash, debtors, etc.) in the Clough Group administration. We will be looking to make payments to that class of creditor as soon as we can. At this stage, we are not able to advise as to when that may be. All employees will continue to be updated as the Administration progresses.

What is the intended realisation strategy for RUC Cementation?

RUC Cementation is a subsidiary of Murray & Roberts Pty Ltd. We are not appointed to RUC Cementation however we own all the equity in RUC Cementation. It is our intention in conjunction and with the permission and consent of the surety providers who have security over Murray & Roberts Pty Ltd to run a sale process to achieve an outcome for the benefit of surety providers in respect to that particular asset.

Do we need to obtain a purchase order from the Administrators for the JV projects or can we accept a JV purchase order?

In relation to JV projects such a as the Future Generation project, Snowy Hydro project, or the Project Energy Connect we encourage you to reach out to the JV as you would have done in the past. We have put in processes and systems to approve the release of funds from the JV bank accounts going forward. We encourage you to continue your arrangements as business as usual.

What will happen to the Clough Australian entities that are not acquired by Webuild? Will they still be managed by the VA team? What is the plan?

In respect to assets or entities that are not acquired by Webuild, they will form what is likely to be described as excluded assets. This is most likely to comprise those projects which are unable to be transferred or will not be transferred as part of a transaction to Webuild. It is our intention to preserve as many jobs as we can and subject to the support of Principals, JV and alliance partners, and clients we will continue to work with those stakeholders to try and preserve those jobs and hand over those projects in an orderly way to those parties.

In respect to other assets which may sit within the Clough Group, be they for example litigation claims or other assets such as plant & equipment and the like, of which there is not a significant dollar value within this Group outside what sits in the JV arrangements, we will be taking action to try and recover those assets as Administrators, or as Deed Administrators, or as Trustees of a Trust, depending on how our appointment will transpire. We will be seeking to recover those for the benefit of creditors.

Could you advise on trading status for the Waitsia Stage 2 Gas Plant and if the Administrators are taking action to endorse subcontracts to allow continuance of works and supplies to this project?

From our perspective, on a week-to-week basis it is business as usual. The Principals on the project, being Mitsui and Beach Energy are putting funds into our account on a weekly basis in advance, to allow us to continue the works on that site.

Can the Administrators advise how their pursuit of the \$350M owed from Murray & Roberts Pty Ltd to Clough is progressing?

There is a loan of c.\$350M from Murray & Roberts Pty Ltd to Clough Group. It is important to note that Murray & Robert Pty Ltd is an entity that is also subject to our appointment as Administrators and therefore that entity is insolvent and any recovery is uncertain.

If the Sale Purchase Agreement with Webuild is completed, does that mean no employees, hired by Webuild or not, will be eligible for FEG after the VA?

If employees are transferred as part of a sale transaction, we will be seeking to preserve their employee entitlements and transfer those across to Webuild. Indeed for those projects that moving forward are not part of any transaction we would also be seeking to hand over those entitlements to the relevant Principal, JV or alliance partner, or client.

Lombrum project/subcontractor with outstanding invoices due and commitments with significant imports of piles. Are we to be paid out of funds currently in hand or not? It is a today decision; significant implications for project if we do not proceed with pile purchase.

Could I request the person asking this question to contact us directly with respect to this matter following this meeting.

For unsecured creditors, what documentation is required to chase up unpaid/outstanding invoices?

In the first instance, we encourage you to continue business as usual. If you wish to lodge a claim in the Administration, you are welcome to do so. We encourage you to attach the outstanding invoices and claims that you may have to that Proof of Debt and lodge this via our Halo platform.

Could you advise/provide the details of the next steps in a clear schedule format to follow and anticipate the next steps?

We will see what we can communicate to the broader group as to the next steps in the Administration and the estimated timeframes of same.

Do you yet have any idea on where future tenders will lay in the purchase or transaction of the Clough entity?

The value of this business in part relates to its pipeline and the conversion of that pipeline. That has informed the speed in which we are working. You will appreciate it is hard for a company in administration to be awarded contracts but possible; it certainly happened on the Probuild Administration. It is our intention to preserve as many future tenders for as many matters in the pipeline as possible for the benefit of any acquiring party. That includes the people associated with the delivery of those projects.

When do you foresee those who left Clough and resigned before the VA to be paid their entitlements?

Unfortunately, at this time we cannot confirm the precise time as to when this payment will be made. We do expect that prior to the next meeting of creditors that we will be able to advise you of our expected timeframe.
