VERDICT, ORDER OR DIRECTION:

Black J makes orders (as amended) in accordance with the Short Minutes of Order initialled by him and placed in the file.

#### THE COURT NOTES THAT:

1A By an order made by consent on 18 March 2022, pursuant to rule 28.2 of the Uniform Civil Procedure Rules 2005 (NSW), the Court reserved for separate determination any dispute (to the extent that it remains) as to the repossession and airworthiness of aircraft objects, howsoever described (including any relocation costs), and as to the Defendants' decision to reject the quantum or a component (rather than the priority) of a claim made by a Plaintiff in whole or in part (Reserved Matters).

### THE COURT ORDERS THAT:

- 1 The proceedings be listed for directions before Black J at 9.15am on 29 April 2022, for no more than 45 minutes, with respect to the Reserved Matters.
- 2 The proceedings otherwise be dismissed.
- 3 Each of the Plaintiffs in each proceeding, other than CIT Aerospace LLC, pay the Defendants' costs of that proceeding to the date of these orders, other than the Reserved Matters, as agreed or as assessed.
- 4 For the avoidance of doubt where the Reserved Matters are still to be determined, pursuant to rule 42.7(2) of the Uniform Civil Procedure Rules 2005 (NSW), the costs orders in paragraph 3 above be payable forthwith.
