4. NOTES TO APPLICANTS

All supporting documentation requested must be supplied.

4.1 Eligibility

Those eligible for an education grant must be a shareholder, or a descendant of a shareholder such as a child, grandchild, great grandchild or great great grandchild.

A member or beneficiary under a Whanau Trust which is listed as a shareholder in the Tatua 3B Trust Register is also eligible for an education grant.

The Maori Land on Line website <http://www.maorilandonline.govt.nz> is useful for checking Maori Land Owner interests. When you correctly enter an Owner's (Shareholder's) Firstname(s) and Last Name a full list of land blocks will be displayed for that owner. The land blocks are listed alphabetically with the owner's name headed above each block name. Check that Tatua 3B is on the list.

4.2 Priority

Priority will be given to full time students at an accredited tertiary education institution or approved training organisation.

4.3 Bank Deposit Slips

A bank deposit slip must be attached for all first time applicants and past recipients whose Bank Account details have changed.

4.4 Confirmation of Enrolment.

The application form must be accompanied by a letter or certificate from your educational institution that confirms your enrolment. It must include:

- a) The Name of the Institution – preferably on their letterhead.
- b) Name of the student.
- c) Programme or course of study being undertaken.
- d) Year of study.
- e) Signed and dated by the Registrar or Head of Department or other authorised officer.

OR

- f) A receipt for fees paid (fee receipt from a Student Loan is acceptable).
