	Title (English)	:	Acceleration of Renewable Energy Development for Electricity Supply

### <u>Summary</u>

The acceleration of renewable energy development for electricity supply purposes is regulated in the Presidential Decree of the Republic of Indonesia Number 112 of 2022. This decree determines purchasing price of electricity from power plants that utilizes renewable energy by PT PLN, including highest benchmark price or deal price with or without taking into account of the location factor (F); of the location factor (F); Another aspect that is determined by this decree is the purchasing price of electricity from power plants that is fully established by business entities. This decree further regulates the practice of electricity purchase, consisting of electricity purchase from power plants that is fully established by the central government or regional government including those financed with grant. Additionally, this decree also regulates electricity purchase agreement; government's support that is given in the form of incentive; guidance and supervision; and terms for transition. Lastly, this decree contains appendix that encloses prices of electricity purchase from various types of renewable energy.

This regulation is in effect starting 13 September 2022.

#### <u>Summary</u>

According to the recommendation by Evaluating Team for the Procurement of Biofuel-Type Biodiesel, there are several adjustments in Biodiesel Fuel needs and provisions of Article 13 and Article 15 of Regulation of the Minister of Energy and Mineral Resources Number 24 of 2021, it is necessary to adjust volume allocation of Biodiesel for Biodiesel-Type Biofuel Business Entity. In this Decree of the Minister of Energy and Mineral Resources, there are several provisions that need to be amended in the Decree of the Minister of Energy and Mineral Resources Number 150.K/EK.05/DJE/2021 as amended in the Decree of the Minister of Energy and Mineral Resources Number 150.K/EK.05/DJE/2021 as amended in the Decree of the Minister of Energy and Mineral Resources Number 154.K/EK.05/DJE/2022. The amendment includes adjustment to the total of Biodiesel volume allocation to 11.025.604 kL and adjustment to the Appendix that contains a List of Oil Fuel Business Entity and Biodiesel-Type Biofuel Business Entity, as well as the Allocation of Biodiesel for Gas Oil Mixing in the Period of January-December 2022. At the time that this Minister Decree is in effect, the Second Dictum and the

Appendix of the Decree of the Minister of Energy and Mineral Resources Number 150.K/EK.05/DJE/2021 is revoked and declared void.

#### <u>Summary</u>

The Decree of the Minister of Energy and Resources number 227.K/MB.01/MEM.B/2022 establishes the reference price of metal minerals and reference price of coal for September 2022. The metal mineral commodities mentioned in this Decree are nickel, cobalt, lead, zinc, aluminium, copper, forms of gold, forms of silver, forms of tin, manganese, iron ore, chrome ore, ilmenite concentrate, and titanium concentrate. There are different reference prices for each commodity as seen in the appendix of the Decree. The reference price for coal is 319,22 USD/ton.

This regulation is in effect starting 12 September 2022.

#### <u>Summary</u>

In order to create guidelines in compensation price calculation formula of information data on mining business areas permit and special mining business areas permit, it is necessary to regulate the calculation formula in this regard. The calculation formula will be outlined based on data and information gathered from investigation dan research and/or exploration that includes data that indicates metal or coal mineralization in the soft copy or raw data form; data of potential and/or reserve metal and coal mineralization in the soft copy or raw data form; report of exploration and/or report of mineral resources and/or reserve authorized by a qualified person in case raw data is unavailable. The formula to calculate information data on mining business areas permit and special mining business areas permit will require values of Influence Coefficient Data, Exploration Area Value per Hectare, Area Maturity, Data Valuation, Data Type and Value per Data Type. This regulation will revoke the Decree of Minister of Energy and Mineral Resources Number 80/K/32/MEM/2020.

Title (English)	:	Retail Prices for Certain Types of Fuel Oil and Assignment-Specific Types of Fuel Oil

### <u>Summary</u>

Adjustment in retail prices for certain types of fuel oil and assignment-specific types of fuel oil is necessary with the escalation of crude oil price and to aid the public's purchasing power with accurate fuel oil subsidy alteration in the form of remuneration and social assistance. This Decree of the Minister of Energy and Mineral Resources regulates retail price for Certain Types of Fuel Oil, including kerosene for Rp2.500,00 per litre including Value Added Tax and gas oil for Rp6.800,00 per litre including Value Added Tax and Motored Vehicle Fuel Tax; as well as Assignment-Specific Types of Fuel Oil of gasoline RON 90 for Rp10.000,00 per litre including Value Added Tax and Motored Vehicle Fuel Tax. These retail prices will be in effect starting 3 September 2022. This regulation revokes the Decree of the Minister of Energy and Mineral Resources Number 125.K/HK.02/MEM.M/2021 concerning Retail Sales Prices for Certain Types of Fuel Oil and Assignment-Specific Types of Fuel Oil as well as the Third Dictum of the Decree of the Minister of Energy and Mineral Resources Number 37.K/HK.02/MEM.M/2022 concerning Assignment-Specific Types of Fuel Oil.

#### **Summary**

This Decree of the Minister of Trade regulates Export Benchmark Prices starting 1 September 2022 to 30 September 2022 and includes Items Description and Export Benchmark Price of these items. Copper concentrate of various components, iron (hematite, magnetite) concentrate of various components, laterite iron (gutit, hematite, magnetite) concentrate of various components, manganese concentrate of various components, lead concentrate of various components, zinc concentrate of various components, lamella magnetite-ilmenite concentrate of various components, lamella magnetiteilmenite concentrate pellet of various components, ilmenite concentrate of various components, rutile concentrate of various components, and washed bauxite of various components.

This regulation is in effect starting 1 September 2022.
