## 泰国 BOI 快讯

针对四项特别投资措施的申请期限将延期

### 引言

泰国投资促进委员会("BOI")近日宣布,以下四项特别措施的申请期限将准予延期:

- 1) 保留与扩展投资的措施
- 2) 整体生产场地搬迁的措施
- 3) 经济复苏投资激励措施
- 4) 汽车产业升级促进措施

### 主要内容

原计划要求投资者在 2024 年最后一个工作日之前提交上述四项特别措施的投资促进申请。根据 BOI 于 2024 年 11 月 1 日发布的第 151/2567号新闻稿(O.71),BOI 现已将申请截止日期延长至 2025 年最后一个工作日。

此外, BOI 对这四项措施的若干条件进行了调整, 以适应当前的投资环境。例如, 针对经济复苏投资激励措施的最低实际投资额要求, 已从

最初的 10 亿泰铢提高至 20 亿泰铢。BOI 将在后续公告中提供更多详细信息。

建议有意向申请这四项特别措施的外国及泰国本土企业,审查其业务活动、投资计划及项目时间表,考虑是否能够在 2024 年最后一个工作日之前提交申请。在此日期之后提交的申请,将适用四项措施更新后的激励条件。
