## REVENUE MEMORANDUM CIRCULAR NO. 119 - 2024

**SUBJECT** 

: Providing Extension of the Deadlines for the Filing of Tax Returns and Payment of the Corresponding Taxes Due Thereon, Including Submission of Required Documents for Taxpayers within the Jurisdiction of Revenue District Offices of the Bureau of Internal Revenue that were Affected by Typhoon "Kristine"

TO

: All Internal Revenue Officers And Others Concerned

Pursuant to Revenue Regulations No. 13-2024, this Circular is being issued in order to provide relief to taxpayers taking into account the announcement of the Office of the Executive Secretary of Malacañang suspending government work on October 23, 24 and 25, 2024 in Luzon due to the bad weather condition brought about by Typhoon "Kristine".

The Bureau of Internal Revenue (BIR) is hereby <u>extending</u> the deadline for the filing of tax returns and the payment of taxes due thereon, including submission of certain documents.

The extension is intended to provide ample time for taxpayers and BIR Personnel within the following <u>affected</u> Revenue District Offices (RDOs) including affected Authorized Agent Banks (AABs), to comply with the statutory tax deadlines:

All internal revenue officers and employees are hereby enjoined to follow, observe and give this Revenue Memorandum Circular as wide publicity as possible.

This Circular shall take effect immediately.
