MOF extends e-Invoicing implementation date for MSMEs to 1 January 2026

On 20 February 2025, the Finance Minister II, Senator Datuk Seri Amir Hamzah Azizan announced in Dewan Rakyat that the implementation of e-Invoicing for Micro, Small and Medium Enterprises (MSMEs) with annual sales between RM150,000 and RM500,000 will be postponed to 1 January 2026 (instead of 1 July 2025).

He said that the six-month transition period would benefit over 240,000 MSMEs, providing them with adequate preparation time for the implementation of e-Invoicing.
