# Legal Alert May 2025 Where legal meets business

## DBD has implemented the DBD Biz Regist, a digital platform for online registration

Following recent news and update regarding the Department of Business Development's ("DBD") initiative to enhance public services through technology, aiming to improve convenience, timeline, and cost-efficiency, the DBD has introduced a new digital platform called "DBD Biz Regist." This platform allows for the online submission of corporate registration changes for limited companies and became available since January 2025. While the traditional walk-in registration process will remain available during the initial phase, the DBD plans to make online registration the sole method starting from 1 July 2025.

The DBD no longer offers the option to reserve appointments for on-site registration. According to the guidelines, all on-site submissions must be made on a walk-in basis. The Central Registration Office and DBD Offices in Areas 1 to 6 will limit each officer to processing limited numbers of applications per day, meaning registration completion on site will depend on the number of officers on duty.

This system simplifies the registration process for both Thai and foreign operators, making it more simplified to register a company or other corporate changes with the DBD.


