



## **Comprehensive Services Coordinator (Ref: KHSZ/CSC/03-22)**

### **Background**

Deloitte Tanzania has been awarded a contract to implement a Kizazi Hodari – Southern Zone project in Tanzania. This is a five years' project (March 2022 to February 2027) funded by the American People through USAID aiming at supporting the Government of Tanzania's (GOT) Ministry of Health to achieve HIV epidemic control by improving the health, well-being, and protection of Orphans and Vulnerable Children (OVC) and youth in high HIV burden communities within the Southern Zones of Tanzania specifically Iringa, Njombe and Ruvuma regions. The program intends to increase access to and use of health/HIV, social, and protection services among OVC and youth in order to contribute to 95-95-95 goals: 95% of persons living with HIV (PLHIV) know their HIV status; 95% of PLHIV who know their status are on treatment; and 95% of PLHIV on treatment are virally suppressed, by 2030.

Deloitte is therefore seeking for experienced, self-motivated, a highly competent individual with exemplary ethical conduct to join Kizazi Hodari – Southern Zone program as a **Comprehensive Services Coordinator** based in Dar es Salaam region.

### **Job Purpose:**

Will be responsible to ensure the implementation of Kizazi Hodari 95-95-95 strategy. She/He will support implementation and monitoring of comprehensive model within Kizazi Hodari implementation. Ensure developed effective coordination, collaboration, strategic partnerships and /or linkages and referrals of beneficiaries to comprehensive services through integration of clinical based HIV/AIDS services with community based primary health care and social services. She/he will develop a close working relationship with other coordinators, regional teams and sub grantees.

### **Key Responsibilities:**

- Support, integrate and link interventions predominantly at the community and clinical levels with 20 councils to ensure provision of comprehensive services to OVC households.
- Ensure functional referral system through monitoring, success and challenges of referrals system and provide technical support and advise to troubleshoot and solve identified problems.
- Review SOPs, guidelines and tools recommended for implementation of effective HIV continuum of care and bi-directional referral linkages system.
- Work with other Coordinators to ensure all recommended SOPs and other materials have clearly stated links to HIV services and outcomes and that strategies are in line with the National and International standards.
- Develop close working relationship with government, Sub grantees and private sector to improve access to HIV cascade and education services for eligible OVC and households.
- Lead the process to develop or update inventory for identifying and refer beneficiaries.
- In collaboration with other coordinators enhance GBV/VAC reporting and coordination
- Establish evidence on OVC program contribution to retention to care and viral load suppression for pediatric and adolescent living with HIV.

- Work with M&E team to monitor referral completion, identify challenges and guide regional team on possible solutions.
- Support collaboration with Care and Treatment partners to coordinate and conduct community-based HIV testing.
- In collaboration with HIV Prevention Coordinator ensure availability of PreP in accordance with government guidance.
- In collaboration with Regional teams and CSOs ensure pre and in-service training for CCW/CHW, and tracking CCW/CHW monthly meetings progress
- Support development/compile activity, monthly, progress, quarterly, biannual and annual reports and share with Technical & QI Manager and Results Management Office Manager for further review and inputs.
- Develop responses to ad hoc donor requests

### **Requirements**

- Degree in Medicine, or Public Health or any other related field.
- A minimum of 5 years relevant working experience with 3 years at managerial level
- Experience with PEPFAR 3.0 funded projects in Tanzania
- Knowledge of the components of functional bidirectional referral system
- Understanding of evidence-based HIV prevention, testing, and/or care and treatment.
- Technical expertise in OVC care and support, violence prevention and response, early childhood and adolescent development and education
