#### **Dr Martyn Davies**

Dr Martyn Davies is the Managing Director of Emerging Markets, Deloitte and Dean of the firm's School of Leadership, Alchemy by Deloitte. Martyn is an alumnus of the World Economic Forum's Young Global Leader community, an honour bestowed by the World Economic Forum each year to recognise the most distinguished young leaders nominated below the age of 40 from around the world and has served as a Global Agenda Council member of the World Economic Forum. He is a member of the prestigious Young President's Organisation (YPO), a global network of young chief executives across 130 countries. He is a Senior Fellow at the Mastercard Center for Inclusive Growth – a group comprising leading international economists which works on subjects relating to macro-economics and inclusive growth. Martyn is widely quoted in the news media and his commentary have been published by the BBC, Bloomberg, CCTV, CNBC, the Economist, the Financial Times, the Wall Street Journal and the Washington Post. He is a Visiting Professor at IE Business School, Madrid, Spain and is a Non-Executive Director of the NEPAD Business Foundation as well as Apolitical, a non-governmental organization training young people for public service. Martyn has been educated at Wits, Yonsei (Seoul), Harvard, Oxford and Yale universities.

Prof. Rasoava Rijamampianina is an international visiting faculty at leading institutions in Africa, Asia and Europe. Previously, he held various leadership and directorship positions, including the Academic Directorship, the Directorship of the Senior Executive Programme for Southern Africa – a joint initiative of the Wits Business School and Harvard Business School (USA), and the Management Advancement Programme at the Wits Business School (South Africa). Rija as he is affectionately known, was also a Senior Research Associate in the Faculty of Economics and Business Administration at Hokkaido University (Japan) and an auditor-consultant at Delta Audit Deloitte & Touche (Madagascar) for many years. He holds a DSSC and DESCA from the National Institute of Accounting, Science and Business Administration INSCAE (Madagascar), an MBA from Otaru University of Commerce (Japan), and a DBA degree from Hokkaido University (Japan). His research and teaching interests include multicultural/diversity management, talent management, leadership and change. His work has resulted in numerous publications in scholarly journals and international conference proceedings. He is an editorial board member of various international academic journals and a member of several international academic associations, with many of these based in Japan.
