### Experts have revealed the most hacked social network accounts

Accounts of users of VKontakte, Instagram, as well as Telegram and WhatsApp messengers are the most vulnerable to hacking attempts. But social networks are not the only ones vulnerable to attacks. For example, hackers hacked the servers of a cosmetics company and released an 809 GB archive of more than 1.3 million passport scans of stolen Russian citizens.

### Pirate sites generate more than 1 billion dollar a year

Pirate sites make about \$ 1.3 billion a year. According to Izvestia TV, analysts surveyed 6,000 websites and 900 applications. The portals have unlicensed software and are involved in illegal traffic. Big brands account for 4% of advertising on pirated portals and 24% of advertising in applications. Most ads are clickbait. According to experts, such advertising damages the reputation of large brands.

### The volume of online payments has increased in Kazakhstan

The volume of non-cash payments increased 2.4 times during the year and amounted to almost 30 trillion tenge. The coronavirus pandemic has made adjustments to the activities of small and medium enterprises. The SME sector is suffering the most from the pandemic. Self-isolation and locking continue to negatively affect the performance of small companies. Many entrepreneurs had to suspend their activities temporarily. Until August of this year, the number of small enterprises temporarily not operating increased by 19.3 thousand.
