OTIV wins Deloitte's Technology Fast 50 with a growth of 4366%

Conveo.ai wins the Rising Star award

Ghent-based company OTIV wins Deloitte's 2025 Technology Fast 50 award, becoming the fastest-growing tech company in Belgium, following their Rising Star win in 2023. With a remarkable 4,365.52% revenue growth in the past four years, OTIV not only topped the Fast 50 list, but also received the award for the fastest-growing company in the Mobility category. Founded in 2020 by Niels Van Damme and Sam De Smet, OTIV is specialized in rail automation and focusing on fully self-driving trains. Offering driver assistance, remote operation and full self-driving solutions, the company is working together with the leading global railway operators.
