Eureka launches call for joint project proposals between Austria, Belgium, Chile, France, and Spain

On 12 December 2022, Eureka—the world’s biggest public network for international cooperation in R&D and innovation—launched a new call for **joint projects between Austria, Belgium, Chile, France, and Spain**.

Founded in 1985 from an agreement between 18 member countries, Eureka has a presence in 49 countries in Europe and beyond. In 2021, the total funding amount reached EUR 682.5 million across 200 projects, from both public and private investment in different sectors.

The call invites projects in all areas or application domains, but with a special focus on **low carbon emissions**, such as the following fields:

- Renewable energies;
- Energy efficiency, energy distribution, and storage efficiency;
- Green hydrogen;
- Waste2Energy, waste management and the circular economy, circular materials, eco-design, and recycling;
- Green infrastructure;
- Transport; and
- Agriculture and forestry.

Administrative considerations

The submission deadline for projects is **24 February 2023**. Project consortia must include at least **two firms from two different countries** participating in the

call; research institutes or universities and other organisations are welcome in accordance with the country's funding regulations. Funding will be given to eligible partners by the relevant national authority. Participants from Belgium can apply for funding from VLAIO (Flanders), SPW Research (Wallonia), or INNOVIRIS (Brussels), by submitting their projects to the respective entity.
