**Ligji nr. 7/2022 'Për një ndryshim në ligjin nr. 9723, datë 03.05.2007, "Për Regjistrimin e Biznesit", të ndryshuar'**

Kuvendi i Republikës së Shqipërisë, me datë 27.01.2022 ka miratuar Ligjin nr. 7/2022, i cili ndryshon më tej Ligjin nr. 9723, datë 03.05.2007, "Për regjistrimin e biznesit", të ndryshuar. Ky ndryshim synon të vendosë sanksione administrative më proporcionale dhe bindëse, duke adresuar kështu rekomandimet e "Financial Action Task Force" në raportin e progresit për Shqipërinë në tetor 2021, sipas së cilave Shqipëria duhet të sigurojë një kuadër ligjor të përshtatshëm për shkeljet e detyrimeve të regjistrimit për entitetet ligjore dhe OJF-të.

Konkretisht, Ligji nr. 7/2022 ndryshon nenin 74, pikat 2 dhe 3 të Ligjit nr. 9723, datë 03.05.2007, duke dënuar kundravajtjen administrative, që rezulton nga deklarimi në regjistër i të dhënave të pavërteta dhe moskryerja e regjistrimeve të detyrueshme brenda afateve të parashikuara, jo më me një gjobë prej 15 000 (pesëmbëdhjetë mijë) lekësh por tashmë prej 60 000 (gjashtëdhjetë mijë) lekësh.

**Ligji është publikuar në Fletoren Zyrtare nr. 25, date 15.02.2022 dhe do të hyjë në fuqi 15 dite pas publikimit të saj.**

**Law no. 7/2022 'On an amendment to law no. 9723, dated 03.05.2007, "On Business Registration", as amended'**

The Parliament of the Republic of Albania, on 27.01.2022 has approved Law no. 7/2022 which further amends Law no. 9723, dated 03.05.2007, "On business registration", as amended. This amendment aims to impose more proportional and persuasive administrative sanctions, thus addressing the recommendations of the Financial Action Task Force in the progress report for Albania in October 2021, according to which Albania needs to provide an adequate legal framework for violations of registration obligations for legal entities and NGOs.

Specifically, Law no. 7/2022 amends article 74, points 2 and 3 of Law no. 9723, dated 03.05.2007, sanctioning the administrative offense, that results from the declaration of untrue data in the register and the non-performance of the obligatory registrations within the foreseen time limit, no longer with a fine of 15 000 (fifteen thousand) ALL, but of 60 000 (sixty thousand) ALL.

**The Law has been published with the Official Gazette no. 25, dated 15.02.2022 and will enter into force 15 days after its publication.**
