

## Ndryshime në nivelin e pagës minimale e maksimale në shkallë vendi

Me efekt nga data 01.09.2022, paga minimale mujore bruto në shkallë vendi do të ndryshojë nga 32,000 lekë në 34,000 lekë. Kjo vlerë do të shërbejë si kufiri minimal për efekt të llogaritjes së kontributeve të sigurimeve shoqërore e shëndetësore.

Sipas njoftimit zyrtar të Drejtorisë së Përgjithshme të Tatimeve dhe në përputhje me pikën 2 të nenit 10 të ligjit nr. 7703, datë 11.05.1993 "Për sigurimet shoqërore në Republikën e Shqipërisë", paga maksimale për efekt të llogaritjes së kontributeve të sigurimeve shoqërore do të indeksohet në të njëjtën kohë dhe në atë masë që indeksohet paga minimale në shkallë vendi. Për rrjedhojë, paga e re maksimale për efekt të llogaritjes së kontributeve të sigurimeve shoqërore do të rritet nga 141,133 lekë në 149,954 lekë.

Këto ndryshime janë bërë nëpërmjet Vendimit nr. 604, datë 14.09.2022 "Për përcaktimin e pagës minimale në shkallë vendi", pjesë e paketës së re të rezistencës sociale. Vendimi nr. 604 është publikuar në Fletoren Zyrtare nr. 124 datë 16.09.2022.

## Changes in the minimum and maximum salary on national level

Effective from 01.09.2022, the minimum gross monthly salary on national level changes from ALL 32,000 to ALL 34,000. This value will serve as the minimum limit for the purpose of calculating the social and health insurance contributions.

According to the official notification of the General Tax Directorate and in compliance with point 2 of article 10 of the law no. 7703, dated 11.05.1993 "On social security in the Republic of Albania", the maximum salary for social security purposes is indexed simultaneously and at the same extent as the minimum salary for social security purposes. Consequently, the new maximum salary for the purpose of calculating social security contributions will increase from ALL 141,133 to ALL 149,954.

These amendments have been done through the Decision no. 604, dated 14.09.2022 "On determining the minimum salary on national level", part of the new social resilience package. The Decision no. 604 was published in the Official Gazette no. 124, dated 16.09.2022.
