Cyprus Tax News

Payments of Withholding Tax and Contributions (PAYE)

The Tax Department has announced that starting from **1 July 2025**, payments for Pay as You Earn (**PAYE**) cannot be made through the Tax Portal.

This change is due to the ongoing transfer of the Withholding Tax and Contributions Declaration (TD7) to the new system Tax For All (TFA), necessitating a temporary suspension of the Tax Department's computer systems for scheduled upgrades, detailed as follows:

- Tax For All (TFA): 05/07/2025 to 20/07/2025
- Tax Portal: 05/07/2025 to 06/07/2025

During the aforementioned dates, access to both systems and the associated services will not be available

In accordance with the new legislative requirements, a Withholding Tax and Contributions Declaration needs to be submitted on a monthly basis. The monthly TD7 is a separate declaration that does not include all the fields contained in the annual TD7. It is a replacement of the PAYE on the Tax Portal.

The introduction of monthly declarations for the year 2025 through TFA will commence once the necessary procedures and checks have been completed. After the transfer of PAYE to TFA, employers will need to retroactively submit all pending monthly declarations starting from January 2025 onwards.

Once the monthly TD7 is successfully submitted, obligations will be automatically generated. Corresponding payments can be made via TFA using a credit/debit card or via Internet Banking or at the counters of banks that offer this service, using the payment reference number from the TFA system.
