# Large Dutch manufacturer ensures strong compliancy and reputation safeguarding through automation

Dutch manufacturer automates inward processing procedure, turning a seemingly impossible process into a simple one with TrackonTrade.

#### **Client issue**

A large Dutch manufacturer was challenged with paying import duties for individual parts needed to build their machines. To solve this issue, they realized they needed a comprehensive system to manage the process, minimize the risk of retroactive payments, and ensure compliance with regulations.

The manufacturer imported parts from outside the EU. Normally, it would have to pay import duties for each part. However, through a procedure called inward processing, they could process the parts into finished products and pay only for the final product - as long as customs could confirm that all parts are used.

To meet this requirement, the manufacturer had to keep a detailed record of all 25,000 parts used in their machines. This record-keeping process must be transparent and efficient, because goods can only leave the port after clearance. Handling this manually is impossible, so, the manufacturer partnered with a software provider to create an administration system that took three years to develop. During this time, the manufacturer did not pay import duties, increasing the risks involved with paying retroactively for past years.


