Online public record research

Deloitte's researchers can access **numerous online public record databases**, ranging from those with global coverage to individual jurisdiction-specific records (including media database, corporate registry records, litigation databases, and asset registries).



Social media analysis

The sheer volume of publicly-accessible data available through social media platforms globally necessitates the use of **specialised tools to analyse media profiles**. Deloitte has extensive experience of using such tools to draw out the data needed.



Human intelligence (market interviews)

Our network of well-informed and discreet sources external to Deloitte, operating in various industries and jurisdictions globally, can **provide valuable personal knowledge and insights** on a Subject's background and activities which are not publicly reported.



Manual retrieval of local and hard copy public records

In many databases, key public record resources (such corporate registry data and court records) are not accessible online. We maintain a network of record retrieval agents who can support with the **quick and cost-effective retrieval of local documentation**.



Physical site visits

Sometimes a physical visit of a location is required, for example to gather information on the particular use of a property (such as confirming legal entities at that location, or the nature of activities visible at the site). We have **access to agents globally to undertake these visits**.


We can use our information-gathering methodologies to support a range of projects – from small ad hoc checks, to huge and ongoing investigations

Asset & lifestyle checks

- Asset searches in any jurisdiction of interest, focused on assets with the highest potential for value recovery
- Asset verification to confirm the ownership and value of key assets
- Lifestyle checks to establish whether a subject is living beyond their official means

Background & biographies

- Event research for example, compiling chronologies of key events, to support disputes and litigation
- Biographies profiles of individuals identified during an investigation to better understand the findings



Connections analysis

- Network analysis individual and corporate network identification, mapping & analysis, to identify linked individuals and businesses
- Connections analysis a form of network analysis focused specifically on identifying connections between two parties or groups

Other intelligence services

- Integrity Due Diligence information on the background, reputation and integrity of key individuals and entities
- Market Entry Intelligence country and political risk analysis on the risks of a western operator entering a particular jurisdiction or sector

Ongoing ad hoc research for a UK Government Department

A UK government department was seeking to enforce legislation against a large number of UK-based companies, and wanted to gain an understanding of how these companies were structured, their key UK-based assets, and whether they were seeking to dispose of these assets.

Over a two-year period, we supported with ad hoc research on individual targets, supporting the client in achieving its goals.

Supporting a global mining group's internal investigations

We provide corporate intelligence support to a global mining group's internal investigation team, supporting them in their assessment of whistle-blower allegations made against employees of the business.

Our work has primarily focused on seeking to confirm allegations of links between the client's employees and staff at providers to the group, in relation to operations in North America, Sub-Saharan Africa and Europe.
