Did you know?

Most National Minimum Wage (NMW) breaches are due to subtle technicalities in the regulations or working practices that aren't visible to the business.

Common pitfalls include...

Working time

Employers must ensure all 'working time' is taken into account and paid at NMW or higher. For workers paid near NMW, any amount of unpaid working time may reduce pay below NMW.

Salary sacrifice

Reductions to gross pay for cars, pensions, childcare etc. reduces pay for NMW purpose. Even where a worker has voluntarily agreed to the deduction.

Net pay deductions

Christmas savings club, fuel card reimbursements, and private mileage usage contributions etc. may reduce pay for NMW purposes. Even where voluntary and they are for the benefit of the worker.

Deemed reductions (outside of payroll)

Prescriptive clothing policies, uniforms or tools which are not provided for free.
