Eligibility and requalifying companies deadline

Company questionnaire

Companies must provide information to confirm eligibility and complete the Best Managed questionnaire.

Applications will be available during the application period only at www.bestmanagedcompanies.ca

Application deadline (First year applicants, Gold Standard, and Platinum Club)

Who?

Who can apply?

Companies wishing to apply must meet the following criteria:

- Revenue greater than \$50M CAD in the most recent year of operations
- Canadian-owned private company; or
- Canadian-owned portfolio company controlled by Canadian venture capital and Canadian private equity firms; or
- Canadian-owned closely held public company with fewer than 50% of their shares or units traded

Ineligible entities include Canadian-owned public companies with more than 50% of their shares or units traded; credit unions, mutual or co-operative insurance companies; subsidiaries of a foreign owned parent; charities and not-for-profit; government/public sector.

Strategy


