
### Our Purpose and Shared Values

#### Youth Climate Summit

#### "Adopt a Family" Christmas Program

#### Non-Profit Alliance of Bermuda

The Non-Profit Alliance of Bermuda is committed to strengthening and unifying Bermudian nonprofits through education. In May 2023, as part of our *Impact* Every Day activities, we continued our partnership with the Non-Profit Alliance to provide a multi-day training session for its clients. Through this initiative, our people volunteered their time and leveraged their expertise to deliver training sessions to 54 persons from non-profit entities. We were delighted to enhance their understanding of topics critical to the sustainability of their organizations, such as budgeting, best practices in recruitment, interpreting financial statements, and developing risk management plans.
