

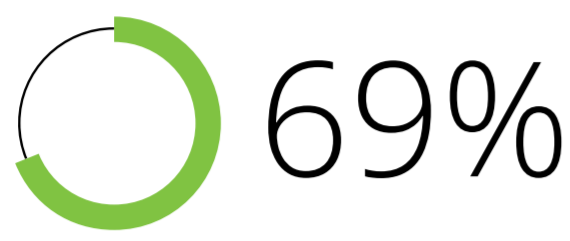

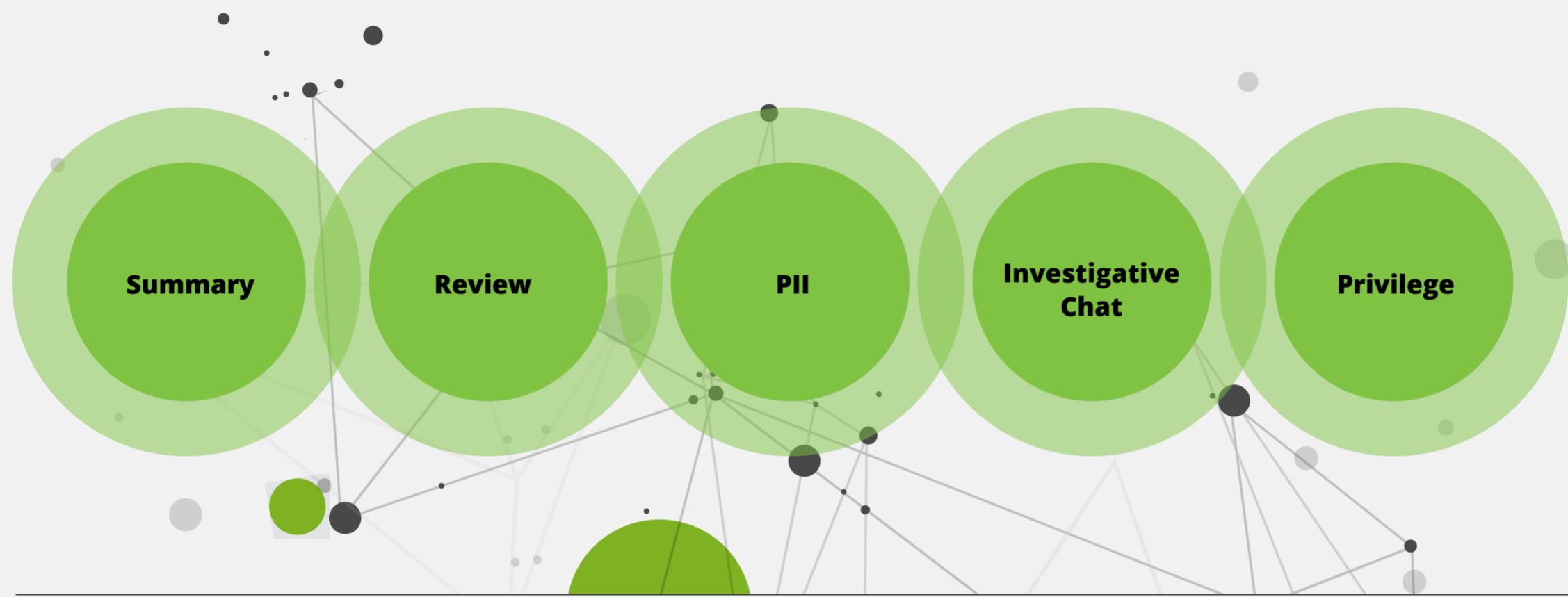

Summarizes the contents of documents while creating high-level cluster descriptions to expedite a coherent, broad understanding.



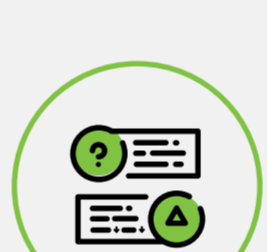
Privilege
