also filed herein on October 24<sup>th</sup>, 2019 the First Affidavit of Edmund Rahming: In support of Winding Up Petition ("First Affidavit").

- 4. At paragraph 24 of the First Affidavit I stated that one of the two shareholders had signed the resolution approving the voluntary liquidation of PGA being put under the supervision of the Supreme Court. I indicated that only one shareholder had signed at the time when the First Affidavit was notarized and the second shareholder had stated that he would sign upon his return to New Providence. Accordingly, I can unequivocally state that the shareholders of PGA have unanimously consented to the voluntary liquidation of PGA being put under the supervision of the Supreme Court of The Bahamas
