 - a. General liquidation costs being allocated to the Trust Assets at 22% and the balance
 of 78% being allocated to PGA proprietary assets;
 - b. Non Sub Fund (segregated accounts associated with the Lyford Diversified Global Fund, SAC) liquidation costs being allocated to the Trusts Assets in proportion to their holding value, and

- c. Global Opportunities EUR NX Sub Fund ("NX Sub Fund") liquidation costs being allocated to the NX Sub Fund Assets only.
- 2. The Official Liquidator for PGA be at liberty to hold back a 2% reserve from which the new Official Liquidator may draw to cover further court approved costs in concluding the liquidation.
- 3. The Official Liquidator for PGA be at liberty to apply.
- 4. The costs of and occasioned by this application be costs in the liquidation.
